"[Here] are the words of an actual hunter-gatherer -- an Inuit from Greenland made famous in the Danish writer Peter Freuchen's Book of the Eskimo. Freuchen tells how one day, after coming home hungry from an unsuccessful walrus-hunting expedition, he found one of the successful hunters dropping off several hundred pounds of meat [for him]. He thanked him profusely. The man objected indignantly:

" 'Up in our country we are human!' said the hunter. 'And since we are human we help each other. We don't like to hear anybody say thanks for that. What I get today you may get tomorrow. Up here we say that by gifts one makes slaves and by whips one makes dogs.'

"The last line is something of an anthropological classic, and similar statements about the refusal to calculate credits and debits can be found through the anthropological literature on egalitarian hunting societies. Rather than seeing himself as human because he could make economic calculations, the hunter insisted that being truly human meant refusing to make such calculations, refusing to measure or remember who had given what to whom, for the precise reason that doing so would inevitably create a world where we began 'comparing power

with power, measuring, calculating' and reducing each other to slaves or dogs through debt."

The goal of the Laura Bush Foundation for America's Libraries is to provide print books to the K-12 school libraries and students that need them the most. Grants of up to \$5,000 are available

#### **Department of State**

The Benjamin Franklin Transatlantic Fellows Summer Institutes program supports summer institutes for youth from Europe and the United States. The institutes will focus on transatlantic relations, leadership development, critical thinking, diplomacy, community activism, and the media as ways that young adults can unite around their common goals. Funds Available for Urban Forestry

#### **Forest Service**

The National Urban and Community Forestry Challenge Cost Share Grant Program supports urban and community forestry projects on nonfederal public land. Priority issues include proposals that demonstrate the connection between the personal benefits of urban forests and quality of life within a community through community engagement, and the design of an urban forestry recruitment program and retention strategies that support existing urban forestry academic curriculum. Pre-proposals are due December 3, 2012. The application deadline is March 15, 2013.

Humanities Research Teams Supported National Endowment for the Humanities The Collaborative Research program provides support for interpretive humanities research undertaken by teams of two or more scholars. The application deadline is December 6, 2012.

Program Funds Safety Training for Commercial Drivers **Department of Transportation** The Commercial Motor Vehicle Operator Safety Training program provides support to expand the number of Commercial Driver's License holders possessing operator safety training in order to reduce the severity and number of crashes on U.S. roads involving commercial motor vehicles. # **Innovative Education Program Championed by the Bay Area Council Showing Results**

A game-changing pilot project to increase student achievement that the Bay Area Council helped introduce at a Marin County school district and hopes to see replicated elsewhere got strong marks during a recent report on its progress. The project at the San Rafael City Schools is modeled on a similar program introduced by Dr. Jerry Weast, who has been described by some as the Best Superintendent in America, when he was head of the Montgomery public schools in Maryland. Bay Area Council member Jay Paxton of Buchalter/Nemer was instrumental in bringing the program here following a business delegation the Bay Area Council led to Maryland to learn about Weast's program. The program seeks to improve student achievement by incorporating processes and cultural practices of highly effective businesses and educational organizations into the local district, including establishing a Business Advisory Council on which several Bay Area Council members serve. Education was also on the minds of Bay Area Council

members who attended a recent briefing by state Board of Education President Mike Krist on progress implementing California's Common Core State Standards, new rigorous and internationally-benchmarked educational standards that seek to better prepare students to graduate, enter college and pursue a productive career. Thank you to TechNet and the Silicon Valley Education Foundation for co-hosting this event. Kirst described a dauntingly complex agenda to bring state education policies into line with the new standards, which all schools in the state must implement over the next several years. # **Budget Disaster Puts Wildlife in the Crosshairs**

Partisan politics is running amok in Washington and our wildlife is a likely victim. Unless Congress can come to a sensible budget agreement before the year's end, draconian cuts are set to automatically slash funding for endangered species, wildlife law enforcement, national wildlife refuges, and a host of other programs critical to wildlife conservation.

Caring for wildlife shouldn't be about politics. It's something all Americans want -- and we can't allow budget politics to decimate funding for endangered species.

#### **Living with Wildlife**

As our dwindling wild places become islands in a sea of humanity, clashes between people and wildlife become inevitable.

Defenders has long been at the forefront of efforts to find creative and balanced strategies for reducing or eliminating conflicts between wild animals and their human neighbors. In southern Idaho, Defenders' Wood River Project has partnered with sheep ranchers to find non-lethal ways to discourage wolves from making meals of the sheep flocks.

The success has been stunning. Sheep deaths from wolves have dropped nearly to zero, and local ranchers have become champions for the wolves' return.

The national work readiness credential (NWRC) is based on Equipped for the Future learning standards, which were created as part of the National Institute for Literacy's 10-year standards development initiative.

The goal is a national certification process that affirms job seekers have demonstrated knowledge and skills necessary for successful performance as entry-level workers.

The program is certified by the National Work Readiness Council. The training, testing and assessment certification process was developed by business firms, chambers of commerce, educators, unions, training professionals and state workforce investment boards in founding states, as well as by Junior Achievement Worldwide.
