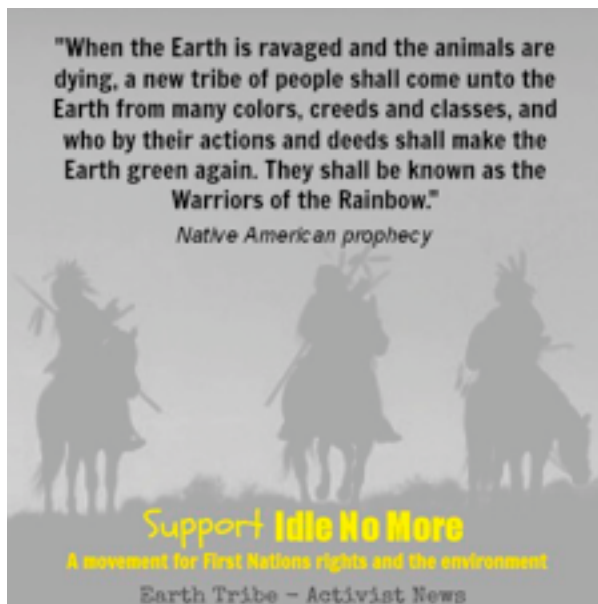

- "Harper is putting the ball in our court while diffusing unity. Canada wants to stop short of recognizing IdleNoMore and Chief Spence's sacrifice because that further legitimizes the movement so we have them announcing a meeting planned Jan.11, among Harper and other 1st Nations chiefs, nothing mentioned of spence or IdleNoMore. I am not satisfied until Harper addresses Spence and the IdleNoMore ladies - appears to be a stall move to me.." Chase Iron Eyes....He is shutting out the movement by calling a meeting on his terms, not Chief Spence.

"In 1990 when we objected to our burial and ceremonial grounds being turned into a golf course, Canada sent 5,000 heavily armed para-military police, RCMP and soldiers to surround us. The Corporation of Canada declared total war on us, using old Greek tactics. The army laid a siege around us. Food was stopped to starve us to death. People were imprisoned. We could not go in or out of the razor wired compound. Energy and communication were turned off. After three months, they demanded we surrender or they would open fire on us. We had to come out. The army brutalized and arrested us. Thousands of people ran to Oka, surrounded the army, helped some of us escape, protected the children and elders. Illegal charges were laid on us, which did not stick. We proved that what we did was political and not criminal. It was under the guidance of the Great Law. We were sanctioned by Creation. Some soldiers told us later they were trained to carry out atrocities on us, such as racial slurs, hitting, spitting, brutalizing the women and children and even stabbing one child in the chest. We learned some strategies ourselves: to stay dispersed; to keep some outside for communication, food runs and bail money; and to organize people to come to our rescue. Today's flash mobs are effective guerilla tactics where we suddenly show up, do a round dance and then leave. LRAD attack LRAD attack During these occasions, security could bring in the cops to surround us, provoke riots, beat and then arrest us. We usually bring our children, so we would be unable to physically resist. They will use the latest crowd control urban warfare methods, such as LRAD, a long range acoustic device and sonic weapon. It sends pain inducing sounds that could burst our ear drums. Now drones can be fired at us legally. In 1990 our sell-outs set up nearby to translate Mohawk into French and to advise the police and army. The time has come for all to assess our native and non-native allies. Afterwards this same elite Canadian airborne regiment was sent to Somalia to commit the same atrocities against the natives there. The UN, US and Canada are the New World Order. We have the goods they want and need. We intend to eliminate the divide and conquer war strategy of the bankers who own the UN, US and Canada corporations. The idea that whoever has the money makes the rules is finished. The bankers' money printing machines will be shattered. They will be arrested and jailed for their fraud and crimes, and deported. The council of Women and the Council of Men will re-establish the peace. It is a natural duty. The land is owned by the future seven generations. We are borrowing it from them. We will do everything necessary to take care of it for them. We are fighting for our identity and rights to control our lives, territories, commerce and way of life. Voices by the Mohawk Nation ♥"

**Cantwell to chair Senate Indian Affairs committee**

**Pending Senate approval, she will be the first woman to lead the Senate committee.**

TULALIP -- Sen. Maria Cantwell, D-Wash., is poised to take on the chairmanship of the U.S.

Senate Committee on Indian Affairs.

Cantwell has been a member of the committee since her first year in the Senate in 2001. The chairmanship, as well as all Senate committee assignments, must get the official stamp of the full Senate when the new Congress convenes in January.

For Tulalip Tribes Chairman Mel Sheldon, the news of Cantwell's proposed assignment is welcome.

"We are so proud of the senator," Sheldon said. "Maria has been a supporter of ours since her legislative service in Olympia. She has continued that at the federal level."

Stillaguamish Tribal Chairman Shawn Yanity in Arlington agreed.

"Maria has a long history of knowing the issues, what the tribes face and who the tribes are," Yanity said. "She has the familiarity with issues such as natural resources, violence against women and many more. We will be leaning a bit more on her to stand stronger on tribal issues. It's really good to have her in that position."

Cantwell said she will be honored to lead the committee as its first female chairman.

"I am proud of my work with our state tribes on issues such as education, health care and the environment, including salmon restoration," Cantwell said. "In our state, the way we work together with the tribes is very relational, but I think that can translate to work with all of the tribal nations in our country."

Cantwell also mentioned her work to promote the sovereignty of tribal nations as well as economic growth among tribes. She has led Senate efforts to give tribal governments more flexibility to lease land and create businesses on reservations.

"The 29 federally recognized tribes in our state contribute greatly to the state's cultural diversity, heritage and economy," Cantwell said. "The tribes in our country are important to our states and our country. I look forward to the opportunities that being the chair of this committee provides."

Sheldon said he shares what he believes is Cantwell's mission as an elected official to give back to the county, the state and the country.

"I've served five years as chairman of the Tulalip Tribes. I couldn't have a better job. Like Maria, I look at this as a once-in-lifetime shot to make life better in Indian Country," Sheldon said. "We look forward to working with her on issues we will face together. She is going to be an active chair for Indian Country."

Cantwell also serves on the Senate committees on Commerce, Science and Transportation, Energy and Natural Resources, Finance and Small Business and Entrepreneurship.

**About the Position:**

The incumbent will be able to perform archeological field surveys to gather technical data and information. He or she will be able to identify and record the exact location and orientation of cultural sites and artifacts using maps, aerial photographs, digital cameras, and/or global positioning systems (GPS) receivers. The archeological technician would be able to monitor archeological projects to ensure sufficiency of on-site surveying and recording. They will be expected to assist in the preparation of archeological reports, such as cultural resource inventories to document environmental and cultural backgrounds, methodologies, and findings. The selectee will be required to assist in data management and perform routine data entry. Further, the holder of this position will assist in the preparation of archeological and historical information for interpreting cultural sites. District would prefer someone familiar with shovel testing and be able to obtain a moderate red-card (at a minimum).

About the Grasslands:

Since the 1930s, Wise, Montague, and Fannin County has been home to precious natural resources, the Caddo/LBJ National Grasslands. The CLBJ has a diverse recreation program including eight managed campgrounds, over 100 miles of multi-use trails, active oil and gas exploration and development, hunting, fishing, wildfire control, prescribed burning, wildlife management and an active Special Use program.

The Caddo/LBJ National Grasslands is approximately 38,000 acres (LBJ Grasslands- 20,300 + acres, Caddo Grasslands-17,800 + acres). Due to the proximity to the Dallas/Fort Worth metroplex and the small percentage of public lands in Texas, recreation and special uses are steady growing programs.

Hunters can find whitetail deer, Rio Grande turkey, and small game such as rabbits, squirrel, and a few quail. While much of the acreage is open to hunters, families looking for a place to picnic and camp can venture out to one of the area's small lakes and ponds.

The Caddo Grasslands, located in Fannin County, offers the same recreational opportunities as the LBJ. However, the lakes located on the Caddo Grasslands are much larger in size. Paved boat ramps and fishing piers are available from the campground's parking area.

About the Area: The community of Decatur, Texas is 38 miles north of the Fort Worth, Texas metropolitan area and less than an hour from the DFW International Airport. The population as of 2010 was 6,042, an increase of 25% since 2000. The area is a combination of rural and urban communities which make Decatur's community culture "out of the ordinary" but an ideal place to call home. Decatur holds dearly to its western heritage as a stop on the famed Chisholm Trail. Decatur is the county seat for Wise County. The county's current population is 59,127.

Agriculture and the oil and gas industry are the biggest private industries today in the Decatur area but several other major employers make their home in Decatur. Other industries are within a 30 minute commute to Denton, Dallas or Fort Worth without the hassle of big city traffic.

Traffic problems, violent crime and fear are virtually nonexistent. Children are safe without having to sacrifice a quality education. Families are moving here because of award-winning schools and our outstanding regional health facility. Churches of most denominations are located in Decatur and Wise County. Decatur is home to several major hotel chains with numerous restaurants and fast food chains.

Decatur has experienced phenomenal growth in the past several years. Average prices for a three bedroom, two bath home is \$125,000. Rental homes average \$800-\$1,000 a month and government housing is not available.

The climate in Decatur has relatively moderate winters and hot summers. The average winter temperature is around 45 degrees while the summers average 10-12 days above 100 degrees. The annual average precipitation is 42 inches and average snowfall 3.9 inches. Spring and fall seasons provide beautiful weather. Decatur's elevation is 1,111 feet above sea level which is the second highest elevated county seat in the state of Texas. ## BLM restricts sales of wild horses, burros THE ASSOCIATED PRESS Jan. 4, 2013

CARSON CITY - The U.S. Bureau of Land Management has announced new rules restricting the private sale of wild horses and burros.

The rules announced Friday are in response to an investigation of a Colorado livestock hauler who purchased more than 1,700 horses since 2009. The Department of Interior's inspector general is investigating whether any of the horses sold to Tom Davis were taken to slaughter. Wild horses are protected under federal law and selling them for slaughter is illegal.

Sales of wild mustangs and burros will be limited to no more than four within a six-month

period unless prior approval is obtained from a BLM assistant director.

Buyers must also describe where they intend to keep the animals.

About 37,000 wild horses roam Western states. About half are in Nevada.
