**Title:** Evaluating the Effectiveness of State, Local, and Tribal Responses to Violence Committed Against Indian Women Living in Tribal Communities **Deadline:** April 22, 2013

**Eligibility:** In general, NIJ is authorized to make grants to, or enter into contracts or cooperative agreements with States (including territories), units of local government (including federally recognized Indian tribal governments as determined by the Secretary of the Interior), nonprofit and for-profit organizations (including tribal nonprofit or for-profit organizations), institutions of higher education (including tribal institutions of higher education), and certain qualified individuals. For-profit organizations must agree to forgo any profit or management fee. Foreign governments, foreign organizations, and foreign institutions of higher education are not eligible to apply.

NIJ may elect to make awards for applications submitted under this solicitation in future fiscal years, dependent on the merit of the applications and on the availability of appropriations.

Health Impact Assessments in Minnesota Supported

**[Blue Cross and Blue Shield of Minnesota Foundation: Health Impact Project](#)**

The Health Impact Project, a collaboration of the Robert Wood Johnson Foundation and the Pew Charitable Trusts, has issued a request for proposals (RFP) that will fund new health impact assessments (HIA) in Minnesota, through support from the Blue Cross and Blue Shield of Minnesota Foundation. HIAs bring together public input, scientific data, and health expertise to identify the potential health effects of proposed projects and policies, and recommend measures to minimize health risks and capitalize on opportunities to improve health. Through this RFP, three grants of up to \$100,000 each will be provided to identify and address potential health impacts of an upcoming decision in the grantees' communities or the state through the use of HIAs. Eligible organizations include Minnesota-based nonprofits, local agencies, tribal agencies, and educational institutions. State agencies, except regulators of Blue Cross and Blue Shield of Minnesota, are also eligible. Regulating agencies can, however, serve as partners on projects. 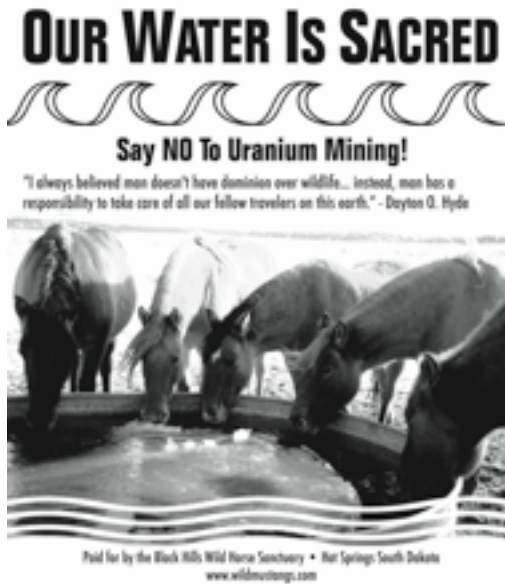
