Stop the Mining Industry from Wasting Nevada's Water Support Assembly Bill 346 in the Nevada legislature
Status

AB 346 has gone through changes, since its first introduction, but it is still a major step forward to prevent wasting water in open pit lakes. At the hearing last week there were no opposing comments, of the amended version of the bill.

This week AB 346 will be discussed in a work session Thursday, April 11. If the bill is not approved by the committee it is dead, so you you continued support of this legislation is critical now.

This bill:

- requires that any mining reclamation permit issued on or after October 1, 2013 contain reclamation of any pit lakes to provide for public access.
- any existing reclamation permit (issued before October 1, 2013) will need to be amended and refiled to also require reclamation of pit lakes to provide public access.
- allows a provision for a mining company to petition the Nevada State Environmental Commission for an exemption to reclaim any pit lakes.

In general there is now a 200 acre surface area cutoff, so any pit lake of less surface area does not need to have a public access point.

This legislation will provide needed direction to the Nevada Department of Environmental Protection.

Good Points to raise:

- To date every pit lake has been granted exemption to reclamation by the Nevada Department of Environmental Protection, so pit lakes are effectively not reclaimed by default. This bill will reverse this situation so that reclamation is the default and sets a much higher bar for an exemption.
- By requiring public access to pit lakes, there will need to be a minimum recreational use standard applied to the water in the pit lake, instead of the current language which only describes a "potential to affect adversely the health of human, terrestrial or avian life." This language is too vague.
- Under current law there will be millions of acre-feet of Nevada's water, once groundwater, that will become unaccessible and useless.
- Under current law without reclamation pit lakes are only required to be fenced off to prevent intrusion. While the water in pit lakes is generally going to be degraded, compared to the pre-mine groundwater, many of the pit lakes will be able to support fish and probably water contact recreation. If they do support fish, it is likely that someone, over the years, will stock the pit lakes with fish able to survive. If that happens, fisherman will want to get down to the pit lakes, and fences, particularly in the rural areas, are not likely to be sufficient to prevent the general public from getting to the pit lakes for recreational fishing. These lakes will thus provide an "attractive nuisance" and unless the pit lake walls are stabilized and a safe access is provided, they will become a dangerous attraction.
- If nothing is done, the pit lakes will remain an attractive nuisance and become a liability for the mining company, and also for the land management agencies.
- The entities that created the pit lakes have a responsibility to provide a productive postmining use that minimizes the risk to the general public.

Growing Number of First Nations Across North America Gather In Ottawa with Unified Message

March 20, Ottawa – Chiefs and hereditary leaders from ten First Nations with traditional territory in the tar sands and on tar sands pipeline routes in western and eastern Canada and the United States gathered in Ottawa today to deliver a clear and unified message: tar sands pipelines will not pass through their collective territories under any conditions or circumstances. The First Nations signed two historic agreements pledging their mutual support to one another in their respective battles to protect their lands, water and health from proposed tar sands projects.

"The International Treaty to Protect the Sacred from Tar Sands Projects and Save the Fraser Declaration are rapidly gaining international support across Canada, the US and beyond. Whether or not Prime Minister Harper or President Obama approves the Enbridge, Kinder Morgan, the Keystone KL or the Enbridge Line 9 pipelines, they will not pass through our collective Aboriginal Territories under any conditions or circumstances," said Hereditary Chief Phil Lane Jr., Ihanktonwan Dakota signatory of the International Treaty to Protect the Sacred from Tar Sands Projects, whose traditional lands include the ecologically sensitive Ogallala aquifer along the route of the Keystone XL pipeline.

Representatives of the Yinka Dene Alliance, the Athabasca Chipewyan First Nation, the Tsleil-Waututh Nation, the Yankton Sioux Nation and the Kitigan Zibi Anishinabeg Nation stood together to demand a cap to tar sands production and say no to further projects.

"Forcing these projects through would contravene our Indigenous laws and our decision-making rights under the Canadian constitution and international law. We have said no, and we call on the



Canadian government to recognize and respect our decisions," said Chief Martin Louie of the Nadleh Whut'en First Nation, which lies in the path of the proposed Enbridge Northern Gateway Pipeline.

The Yinka Dene Alliance, the Kitigan Zibi Anishinabeg

Nation and the Yankton Sioux Nations of South Dakota engaged in mutual signings of the Save the Fraser Declaration and the International Treaty to Protect the Sacred from Tar Sands Projects,

instruments asserting the illegality of tar sands projects under these nations' own Indigenous laws. Leaders fighting the effects of environmental degradation on their rights and culture stressed that building more pipelines will increase tar sands production and destroy Indigenous communities.

"The Canadian government is spending a lot of money and time in the United States saying the tar sands are environmental and well-regulated, but my community -- the polluted air we breathe, the polluted water we drink, the miles of toxic lakes -- is living proof the Canadian government is telling one long, expensive lie," said Chief Allan Adam of the Athabasca Chipewyan First Nation in Alberta.

Four pipelines are being proposed to transport tar sands oil: Enbridge Northern Gateway, Kinder Morgan Trans Mountain, Trans Canada Keystone XL, and the Enbridge Line 9 reversal. First Nations represented along all of these proposed pipelines rejected efforts by government and industry to greenwash these projects and to push them through without consultation, stressing that Canada's energy program must change to meet the challenges.

"We must ensure a clean and healthy world for future generations by providing different solutions. Together we are more empowered than apart. Our resistance is strong and growing and we believe we will succeed," said Rueben George of the Tsleil-Waututh First Nation, which is opposing Kinder Morgan's new pipeline.

The Alberta tar sands currently produce approximately 1.8 million barrels of oil per day, but if industry and government's expansion plans are approved that number could reach six million barrels per day. Analysis by the Pembina Institute shows the projected emissions from the tar sands are increasing Canada's overall emissions. If the tar sands were capped at the current production, Canada's emissions would decrease – not enough to reach the government's 2020 target, but enough to stop Canada from going backwards.

The Save the Fraser Declaration is an Indigenous law declaration banning tar sands pipelines and tankers from crossing British Columbia, signed by over 160 First Nations and supporters since its creation in 2010. The International Treaty to Protect the Sacred Against Tar Sands Projects is a treaty of peace and mutual defense concluded in January 2013 between the Yankton Sioux and Pawnee Nations, marking the 150th anniversary of a historic peace treaty between the two nations and committing signatories to defending their territories and sacred sites from tar sands infrastructure.

Why Enbridge is afraid of Ta'Kaiya Blaney

In my work for Greenpeace I meet special people pretty regularly. And by special, I mean people who do the most unexpected things in the most wonderful ways. Meet Ta'Kaiya. She's a ten-year old girl from North Vancouver who, while learning about sea

otters in her home-school, became concerned about the devastation oil tankers would cause to B.C.'s coast.

When she learned about Enbridge's proposal to build an oil pipeline from the Alberta Tar Sands to the Great Bear Rainforest, bringing more than 200 oil tankers per year to this pristine coast, she got really worried. So, she wrote a <u>song</u> about her concerns. And it's good...really good.

Ta'Kaiya and her mom, Anne, went to Enbridge's office in Vancouver to hand deliver a copy of her music video and a letter that asks them to stop their plans. When she arrived security guards stopped her from going to Enbridge's office on the sixth floor and even entering the building, period. They also refused to send someone down to the street to accept her letter. Apparently Enbridge, who has touted their willingness to listen and work with First Nations, is afraid of a 10-year-old First Nations girl. She is pretty powerful but come on, really? I suppose that is what happens when you speak truth to power...it scares them.

Ta'Kaiya is interviewed by media outside Enbridge's office after being refused entry for trying to deliver her music video and letter to their office.

Ta'Kaiya knows that oil spills are inevitable with oil pipelines and oil tankers. She recorded the song to make a difference for the environment and the cultures that depend on the coast for their livelihood.

If an election isn't triggered already, which seems a certainty, our MPs will be debating Bill C-606 in the House of Commons shortly that would legally ban crude oil tankers from B.C.'s Great Bear Rainforest.

So Ta'Kaiya wrote an open letter to Canada's Members of Parliament (MPs) and sent it to each of them today, on the anniversary of the Exxon Valdez oil spill in Alaska, that urges them to vote in favour of the bill.

Below this blog is her letter and music video. I'm sure you'll agree that with kids like her, our future looks bright. Follow Ta'Kaiya's lead and <u>send your own letter</u> to Prime Minister Stephen Harper urging his government to represent our voices and those of the future that say loud and clear "Protect the Great Bear Rainforest coast!"

Open Letter to Canadian Members of Parliament,

My name is Ta'Kaiya Blaney. I am 10-years-old. I live in North Vancouver and am from the Sliammon Nation. My name means "special water."

I am writing to you because the Enbridge Corporation is planning to build a pipeline from the tar sands of Alberta to Kitimat, BC. I thought it would be very risky for our coast so I wrote a song, called "Shallow Waters" about an oil spill happening in the shallow waters.

You will be debating Bill C-606 soon, if an election is not triggered, which would ban oil tankers from our northwest coast. I am <u>sharing my song's music video</u> and a personal message to encourage you to vote in favour of the bill.

Today is the anniversary of the Exxon Valdez oil spill in Alaska. Even today, 22 years later, oil still remains a few inches under the surface of the water.

With this song, I hope to encourage government officials, people of British Columbia, and people across the world will realize the dangers of oil pollution, replace jobs that **destroy** the environment with jobs that **help** the environment. I ask government and corporate officials such

as yourselves change your plans stop oil tanker traffic on BC's coast and in waters around the world.

- 8. DCP Midstream natural gas compressor explosion in Guthrie Oklahoma (April 4)
- 9. ExxonMobil chemical leak at Chalmette refinery in LOUISIANA (April 3) (apologies for the mistake in the pic)
- 10. S&S Energy oil tanker and gas well explode in Damascus Ohio (April 4)
