Deebege Newe, a Nevada non-profit, has received a grant from the New Mexico Community Foundation to conduct a Native American Awareness Project. The grant purpose, the Native American Awareness Project, is to bring Native American youth (16-30 years of age) together with older activists and elders to communicate the history and values of tribal involvement around the Nevada National Security Site by the use of written materials, translated in part into the Shoshone language that will be used as a learning aid to be distributed at workshops in tribal communities and at special events at higher learning institutions.

Joe Kennedy, President of Deebege Newe stated, "The Western Shoshone



people have need of passing down to the next generation the knowledge of our experience from the testing of nuclear weapons at the Nevada National Security Site." Mr. Kennedy added, "The initial impacts that have resulted in adverse health consequences to our people are long lived. We have learned that by being aware and changing our behavior in the event of a potential exposure to radiation, we can protect our people."

The grant is the second from the New Mexica Community Foundation Community Involvement Fund. Past funding has been used to conduct outreach and education to Native American tribal communites within the influence of the Nevada Nationbal Security Site.

Lewis and Clark? Red Cloud? Buffalo Bill Cody? If South Dakota historian <u>Doane Robinson</u> had his way a century ago, those are the four faces that would be staring majestically into the horizon from the mountain in the Black Hills region of the state. Instead, the faces of four presidents—George Washington, Thomas Jefferson, Theodore Roosevelt and Abraham Lincoln —comprise what remains one of the most breathtaking monuments in our nation, **Mount Rushmore.**

The monument of 60-foot faces, which covers nearly 1,300 acres of rock, was opened on this day in 1941, more than 14 years after construction began. The project was conceived as a way to attract tourism to the area, and the four men originally proposed for the monument played significant roles in building the West. But Danish-American sculptor Gutzon Borglum believed the attraction should be more national in scope, and thus—after President <u>Calvin Coolidge</u> stated that, in addition to Washington, the monument should feature two Republicans and a Democrat—the four presidents were chosen.

It was not built without controversy. The <u>Treaty of Fort Laramie</u> of 1868 had granted the Black Hills to the Lakota tribe in perpetuity. But after the Great Sioux War of 1876, the U.S. seized the land upon the discovery of gold.

Borglum died of an embolism in March 1941, but his project was completed by his son Lincoln. The monument is said to have cost \$989,992.32 to build, and remarkably none of the 400 workers who carved it died during construction. Today, more than 3 million tourists visit the site annually.

<u>Oops</u> Jefferson originally was slated to be on the right side of Washington, but when the rock proved to be too soft the image was dynamited.

Hail to the Red Clouds By Bob Drury and Thomas Clavin, The Washington Post 02 November 13

Bob Drury and Thomas Clavin are the authors of "The Heart of Everything That Is: The Untold Story of Red Cloud, an American Legend."

In June 1870, the most powerful American Indian leader in the country, Red Cloud, arrived in Washington with a contingent of Oglala and Brule Sioux. He was treated as a head of state, given tours of the Capitol and the Washington Navy Yard - where he witnessed a gunnery demonstration - and was feted at a White House reception hosted by President Ulysses S. Grant. The former commander of the Union armies may have recognized the significance of Red Cloud accomplishing in two years what Robert E. Lee could not in four: defeating the United States in a war.

What is called Red Cloud's War officially began in 1866 when the Sioux leader could no longer abide the relentless incursions, including the building of U.S. Army forts, into his people's territory. The high point of the war occurred when he and his field commander Crazy Horse wiped out an Army troop of 81 men. President Andrew Johnson's stunned administration sued for peace. In November 1868, Red Cloud signed a treaty to end the fighting - only after burning the Army forts to the ground.

Less than two years later, Red Cloud was in the nation's capital. "He became stunningly famous," historian R. Eli Paul wrote. "Newspapers recounted his every word and deed, and large crowds of onlookers gathered at every public sighting ."

It is time for Red Cloud to return to Washington - on the professional football team's jerseys and in its fighting spirit.

In <u>an Oct. 9 letter</u> to Washington Redskins season-ticket holders, owner Daniel Snyder reiterated his pride in the team and resisted calls to change its name, which Indian groups and others have proclaimed offensive. Snyder emphasized: "Our past isn't just where we came from - it's who we are."

In <u>a response</u> dated three days later and published in The Washington Post, Robert Brave Heart and George Winzenburg, executive vice president and president, respectively, of the Red Cloud Indian School in South Dakota, declared: "As an organization, Red Cloud Indian School has never - and will never - endorse the use of the name 'Redskins.'" They urged Snyder to "engage in further discussion with Native groups across the country and, ultimately, to move toward changing the name, once and for all."

That discussion can be a short one. The team should be renamed for the great leader who is buried on the Pine Ridge Indian Reservation in South Dakota, a short walk from the school named after him. Such a move would not only ease tension between American Indians and the NFL, but naming the team after Red Cloud would also signify strength, intelligence and perseverance - qualities any NFL team would be proud to project.

Having grown up on the intense rivalries of the NFC East, we agree with Snyder that the team's tradition and past glories are a big part of "who we are" and "where we came from." Which is why we would hate to see his Washington franchise saddled with a generic animal, mineral, geological or meteorological appellation.

The name change from Redskins to Red Clouds would go a long way toward repairing the relationship between the NFL and American Indians. And it would involve minor alterations to the team's logo and even its famous fight song, which could be sung, without missing a beat, as "Hail to the Red Clouds." Red Cloud's profile would be most appealing on jerseys and banners. Finally, there is precedent for naming an NFL franchise after an individual - the Cleveland Browns took their name from their first head coach, Ohio coaching legend Paul Brown.

At the height of his prowess, Red Cloud controlled a multi-tribal empire whose territory spanned one-fifth of the contiguous United States. Moreover, not only did he manage to unite the fractious Sioux clans, bands and tribes into the most fearsome Indian nation in the West, he was a brilliant strategist. Such was his foresight and courage that he was the only Indian to have defeated the United States in not just a battle but a declared war.

Born to an alcoholic father who died soon thereafter, Red Cloud's future appeared dim in the patriarchal Sioux society. Yet he used his insight, innate leadership skills and fearlessness to forge an Indian alliance across the High Plains. Once he led the Sioux to victory over stronger enemies such as the Pawnee and Crow, and co-opted proud tribes such as the Cheyenne and

Arapaho into vassal allies, Red Cloud turned his eye toward the white adventurers, miners and settlers streaming into his territory. They were no match for his military acumen - nor were the U.S. Army officers and soldiers sent to subdue him.

The strategy and tactics designed by Red Cloud and carried out by Crazy Horse - the wiry, young fellow tribesman Red Cloud promoted to field commander - became a guerilla campaign that crippled the Army. Never before had Indians coordinated multiple raids and ambushes hundreds of miles apart or immediately followed up on successful attacks. In December 1866, when his army of braves descended on a frigid battlefield in north-central Wyoming and wiped out the U.S. soldiers under Lt. Col. William Fetterman's command, Red Cloud morphed from a canny guerilla commander to a fearless warrior-chief who brought the U.S. government to its knees.

Red Cloud was one of the most famous American Indians of the 1800s. His trips to Washington to represent the interests of the Sioux and other tribes were covered by newspapers from Chicago to New York to Boston. These same newspapers gave prominent position to his obituary when Red Cloud died in 1909, at age 88.

What football team would not be honored to bear his name? And what general manager and coach would not use Red Cloud's personal story as a template for creating a winning franchise?

Named after such a proud and powerful winner, the Washington Red Clouds would be a lock to emulate their namesake and rout 49ers, defeat Raiders, humiliate Cowboys, pluck Eagles, turn back Texans, break Broncos and generally leave quivering the remaining would-be Giants and Titans of the National Football League.

And that is something for Daniel Snyder to consider.

German intelligence files on ex-Nazis shredded

Investigators have found that in 2007 the German Intelligence Service (BND) destroyed files of 250 BND employees who had been in the Nazi SS or Gestapo.

The BND confirmed the loss, calling it "regrettable and annoying".

Four independent historians are investigating the BND's old links with the Nazis. They say some of the missing papers concern suspected war criminals.

The historians did not allege a deliberate cover-up, but they urged the BND not to destroy any morefiles.

They said the BND should consult them before shredding any more documents, and called for a full investigation into the 2007 incident.

One of the historians, Dresden Professor Klaus-Dietmar Henke, said "it is not the case that the BND somehow deliberately destroyed the files of all those with Nazi links".

According to the BND, the destroyed files relate to about 2% of the archive currently being investigated by the historians. The files were destroyed because they were not deemed to be worth keeping, the BND said.

The investigation into the BND's Nazi roots began in February.

Reinhard Gehlen, who set up the BND after World War II, spied on the Soviet Union for the Nazis during the war.

About 10% of BND recruits during the Cold War had previously served in the SS, the German news website Spiegel reports.

Spiegel says the BND told it that in the 1990s documents about a top wanted Nazi, former SS Capt Alois Brunner, were destroyed. www.bbc.co.uk/news/world-europe-15968698

<u>Jm6P5sDXs3k</u> Published on Aug 5, 2013 Britain's Queen Elizabeth is one of the richest women on earth and much ofher profits are from arms trade including the notorious depleted uranium trade.

The British monarch has managed to increase her wealth from ± 300 million early in her 60-year reign to ± 17 billion at present thanks to investments in arms firms that produce uranium used in depleted uranium (DU) shells, including Rio Tinto Zinc.

DU shells are notorious for their ability to pierce armor and kill targets due to their deadly radioactive features.

The video cites the American nuclear radiation expert Jay M. Gould assaying in his 1996 book titled "The Enemy Within: the High Cost of Living Near Nuclear Reactors" that the British royal family, especially the Queen herself, privately own investments in uranium holding worth some £4 billion through Rio Tinto Zinc.

The mining company, originally named Rio Tinto Mines, was allegedly created for the British Royal family in the late 1950's by Ronald Walter Rowland, the Queen's "buccaneer".

The video argues that the Queen and other royals have been investing in the death trade of depleted uranium globally with little ethical concerns for the consequences of their profiteering. DU weapons were first used by the US military during the first Persian Gulf War against Iraq in 1991.

The US Defense Ministry estimated that between 315 and 350 tons of DU bombs, shells and bullets were fired during the conflict

There are allegations that American and British troops used more than five times as many such weapons as the total number used in the 1991 war in Iraq.

The US has confirmed the use of depleted uranium in both wars but refuses to disclose the scale of the use.

Iraq has seen a sharp rise in the number of children with leukemia and genetic malformation in the decades after the First Persian Gulf War that are attributed to the use of DU weapons.
