REID, HELLER, AMODEI INTRODUCE LEGISLATION ON FISH SPRINGS RANCH SETTLEMENT CONTACT: Kristen Orthman, (202) 224-2939

Washington, D.C. – Nevada Senators Harry Reid and Dean Heller with Congressman Mark Amodei today introduced legislation in both the Senate and House on the Fish Springs Ranch water settlement in Northern Nevada. Since 2005, the Pyramid Lake Paiute Tribe and the Fish Springs Ranch, LLC, have been involved in litigation over a proposed Fish Springs Ranch water project which could have possible impacts to Pyramid Lake.

The Tribe and Vidler have negotiated and finalized a settlement agreement which would allow the water project to move forward in return for \$3.6 million and the transfer of several hundred acres of land to the Tribe. The Tribe will waive its claims to any existing and claimed water rights. This legislation would approve the settlement agreement and would have no cost to taxpayers.

"This is a bipartisan proposal that would simply allow the water settlement between the Pyramid Lake Paiute Tribe and Fish Springs Ranch LLC to move forward without costing a dime," **said Senator Reid.** "The tribe will gain access to nearly \$4 million in settlement funds that they can use for social programs, education and to protect and restore Pyramid Lake, one of Nevada's desert jewels."

"This legislation is an important piece of the puzzle towards moving the settlement forward between the Tribe and Vidler," **said Senator Dean Heller.** "This bipartisan proposal ultimately benefits all parties involved, and I look forward to working with Senator Reid and Representative Amodei to ensure its passage."

"This agreement is another important piece of the infrastructure puzzle for the Truckee Meadows with an eye towards responsible resource use," **said Congressman Amodei.**

America Could End Homelessness in One Year by Doing This

One of the potential obstacles to the National Fish and Wildlife's efforts to deliver water to Walker Lake has been resolved.

The National Fish and Wildlife Foundation, Walker River Paiute Tribe and Bureau of Indian Affairs have reached an agreement on the conveyance of water acquired by NFWF to Walker Lake.

The agreement, which was announced this week but reached in September, will allow water acquired by NFWF as part of the Walker Basin Restoration Program to flow downstream into the lower Walker River through the Walker River Paiute Reservation on its way to Walker Lake.

The three parties were in negotiations for several years, and worked together to develop an agreed upon method to account for and manage the conveyance of the program's water through the reservation.

The foundation said the agreement includes a transparent set of tracking equations and an associated spreadsheet tool to account for natural losses and gains of program water as it flows instream to benefit the lower Walker River and Walker Lake.

The protocols, and the accompanying stipulation for the withdrawal of the protests of Walker River Paiute Tribe and BIS, were submitted to the Nevada State Engineer's Office for consideration as part of Water Rights Change Application No. 80700.

That application proposes to change the place and purpose of use to benefit the Walker River and Walker Lake habitat and fisheries for some of the first water rights acquired for the Walker Basin Restoration Program by NFWF in accordance with the three-party stipulation.

An earlier agreement negotiated with the Walker River Irrigation District, and joined by other protestants, would govern instream administration of the changed water rights upstream of the Wabuska Gage.

The agreement is pursuant to the terms of a separate stipulation submitted to the state engineer in June 2013.

The National Fish and Wildlife Foundation is a nonprofit organization established by Congress in 1984 to protect and restore the nation's fish, wildlife, plants and habitats.

In 2009, NFWF began work to acquire and lease water rights from wiling sellers as part of the Walker Basin Restoration Program.

The program is a comprehensive effort established by Public Law 111-85 to preserve Walker Lake while protecting agricultural, environmental and habitat interests in the Walker River Basin.

Both state engineer and federal decree court approvals are needed to change acquired and leased water rights from irrigation to instream use in order to increase flows into Walker Lake, which has experienced more than a century of lake level decline and increased salinity levels.

Mormon church finally gets race right By Robert A. Rees

The Church of Jesus Christ of Latter-day Saints (Mormon) recently made a historic announcement: A Today, the church disavows the theories advanced in the past that black skin is a sign of divine disfavor or curse, or that it reflects actions in a premortal life; that mixed-race marriages are a sin; or that blacks or people of any other race or ethnicity are inferior in any way to anyone else. Church leaders today unequivocally condemn all racism, past and present, in any form.

This is a major statement, not only for what it says, but that it says it so openly and honestly. Fortunately and helpfully, the announcement provides a full and accurate historical account of how the doctrine of denying the priesthood to blacks of African descent emerged, especially in the period after the founding Prophet Joseph Smith As death in 1844.

Up until that time, Smith not only ordained black men but allowed some blacks to participate in temple ordinances. In addition, he proposed using government funds to free all of the slaves.

As the new announcement makes clear, the origin of the ban on priesthood ordination began with Brigham Young in 1852 after the Mormons had migrated to Utah Territory.

The conversion of Southern slave owners, aversion to miscegenation, and the Compromise of 1850 (which allowed new states and territories the choice between freedom and slavery), led to Young As decision.

That decision, defended by mythology, scripture, and an entrenched racism in American culture, became solidified as doctrine for more than 100 years. It was defended at the highest levels even after the civil rights movement and the shift in American society toward equal rights for all citizens. For many modern Mormons, it became a source of embarrassment.

Although considerable pressure was put on the church to change this practice, it wasn At until 1978 when Mormon President Spencer W. Kimball announced that after long and anguished prayer, God Ahas heard our prayers, and by revelation has confirmed that the long-promised day has come when every faithful, worthy man in the church may receive the holy priesthood. Accordingly, all worthy male members of the church may be ordained to the priesthood without regard for race or color.

That was a day of rejoicing for many Mormons, especially black members who had stayed faithful to the church on the promise that they would one day enjoy the blessings of the priesthood.

The revelation did not end racism in the church, however, because church leaders did not take the next, necessary step of disavowing its racist past.

Many Mormons continued to believe and some even to teach the false doctrines that had become so deeply ingrained in Mormon consciousness over the generations, including that blacks were inheritors of the curse of Cain and that they were not valiant in the preexistence, both of which are explicitly disavowed in the church As latest statement.

The honesty and candor of the church As new statement are refreshing. It follows on the heels of President Dieter Uchtdorf As October conference address, A Come, Join with Us, A in which he stated, And, to be perfectly frank, there have been times when members or leaders in the church have simply made mistakes. There may have been things said or done that were not in harmony with our values, principles, or doctrine.

We may never know what precipitated the new and very welcome statement on A Race and the Priesthood, A but I suspect there are several key factors.

Among these is that, as recent studies have shown, past and present racist attitudes are one of the reasons many contemporary Latter-day Saints are experiencing a crisis of faith. Also relevant is the difficulty of retaining black converts in the United States.

Another factor is the church As expanding mission in Africa, where most members are not even aware of the prior priesthood ban.

Sometimes in human affairs, there is a dramatic alignment of events. Such was the case with the coincidence of the church As acknowledging its past mistakes in the week that saw the passing of Nelson Mandela, the moral conscience of the civilized world on race for the past half century. Church leaders honored Mandela last week for his Acourage, kindness and extraordinary moral leadership [which] have been an example to all people.

There were many Mormons over the past century who also exemplified moral courage in working to end racism and affirm the Book of Mormon scripture that All are alike unto God. A Rejoice! Robert A. Rees, Ph.D., is visiting professor of Mormonism at Graduate Theological Union and UC Berkeley.
