The U.S. Department of Housing and Urban Development (HUD) has announced the availability of \$70 million in Indian Community Development Block Grant (ICDBG) funding as follows:

Approximately:

\$56.2 million for all ICDBG-eligible activities,

\$10 million for mold remediation and prevention, and

\$3.9 million retained to fund Imminent Threat projects.

**BOULDER, Colo.** – The Native American Rights Fund (NARF) has received a commitment for \$5,000 annually from the National Indian Gaming Association, to be used for general operating expenses and special projects. The announcement came on May 13 during the general session at

its annual trade show and conference in San Diego. Simultaneously with the announcement, NIGA issued a challenge to its tribal membership to match their annual commitment to NARF and if possible to give more annually.

“This generous challenge grant will help provide NARF much needed funding for and focus on our legal work insuring the survival of tribes and their ways of life,” said Executive Director John E. Echohawk. “Our deepest thanks go to the National Indian Gaming Association and their dedication to the legal rights of Indian Country.”

NIGA’s challenge to its tribal membership is a testament to the value and impact of NARF’s work. Tribal contributions are extremely important to help underwrite NARF’s vital efforts on behalf of Indian country. NIGA’s tribal membership, through its own action, is taking the lead in helping

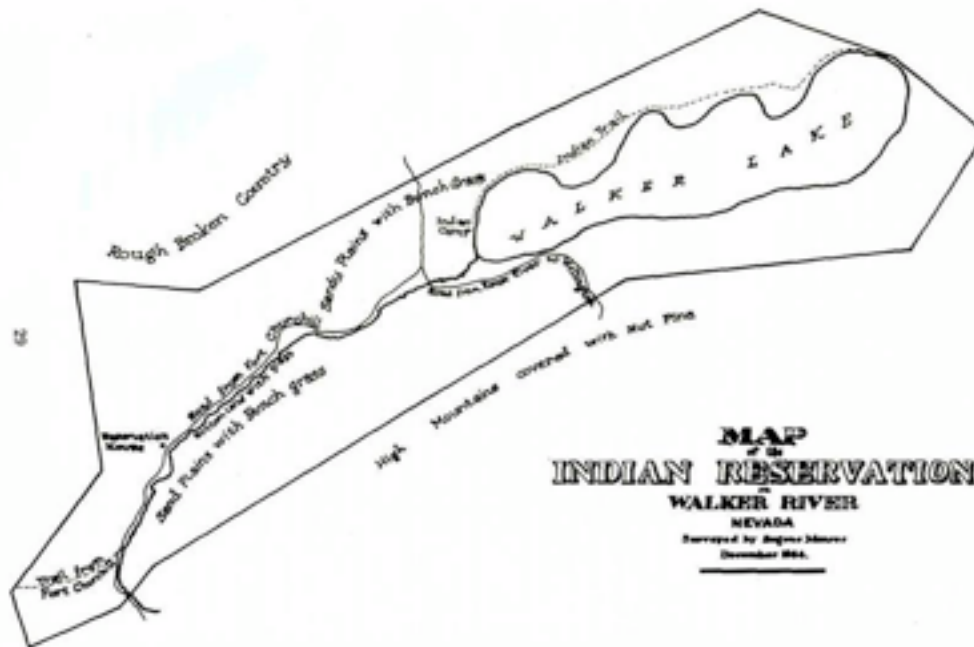

**Mathematicians help California drought-weary berry growers address water issues:** In the Pajaro Valley, berries are the main crop and the main economic driver. However, despite crop rotation and water conservation strategies, overdraft continues to be a problem. So enter the

mathematicians: “ In 2011, a National Science Foundation-funded math institute, the American Institute of Mathematics (AIM) in Palo Alto, Calif., got involved in what they describe as an “optimization problem.” One of eight NSF-funded math institutes, AIM brings 800 mathematicians from around the world to Palo Alto each year to study a “whole variety of programs,” according to its deputy director Estelle Basor. Small research groups with “applied”



objectives come for weeklong stints, modeling neural effects related to migraine headaches, more efficient medical imaging or, in this case, improved water use in drought-stricken areas.
