**Description:** This project would improve, enhance, and protect bi-state sage grouse habitat, increase habitat connectivity, and reduce the risk of high intensity wildfire by reducing pinyon-juniper encroachment using mechanical methods.

#### PROPOSED ACTION

The Forest Service proposes to remove pinyon pine and juniper using a combination of mechanical methods and prescribed fire on up to 41,350 acres within the project area (Figure 3).

Mechanical methods would be emphasized on slopes less than 35 percent and around private lands to reduce the risk of wildfire, improve the health and diversity of vegetation, and improve the quality of wildlife habitat in areas where the use of prescribed fire would not achieve desired objectives or would be difficult to implement.

Neanderthals in Europe Died Out Thousands of Years Sooner Than Some Thought, Study Says By KENNETH CHANG

Ready for this jelly? Strange sea creatures invade West Coast beaches By Jason Kravarik, CNN Tue August 19, 2014

#### **STORY HIGHLIGHTS**

- The palm-sized creatures have a clear, distinctive fin sticking up from a blue, oval body

**Oxnard, California (CNN)** -- Thousands of strange sea creatures are washing ashore on California beaches, puzzling tourists and thrilling scientists quick to explain the phenomenon.

"The scientific name is Velella velella," said David Bader, director of education at the Aquarium of the Pacific in Long Beach, California. "They're jelly-like creatures, but they're not exactly jellyfish."

Also known as "by-the-wind sailors," the creatures have a clear, distinctive fin sticking up from a blue, oval body no larger than the palm of a hand.

"Every now and then, the currents and the winds will change and these guys will, instead of being pushed out to sea, they actually wind up on the beach," Bader told CNN.



They first started showing up in Washington and Oregon, and by mid-July reached San Francisco. On Thursday, photos turned up on Twitter from Hollywood and Silver Strand beaches in Oxnard.

By-the-wind sailors do sting to catch their food, but humans need not worry.

"That sting is not very potent. It's nothing that could actually get through my skin," Bader said while holding an assortment of the creatures.

Velella velella feeds on plankton and fish eggs caught with tentacles that hang down from its jelly-like body. The creatures float on top of the ocean with their fins sticking straight up, leaving them at the mercy of the wind and the current.

"Out at sea, they look like bubbles on the surface of the ocean until you get up on them," said Julie Bursek of

NOAA's Channel Islands National Marine Sanctuary.

They don't live long on the shore, causing their deep blue color to fade until their clear, tougher fins are all that's left behind.



Through a series of interviews with the Hood River Middle School faculty and the design team, we explore the creation of a net-zero-energy building that complements the children's studies of the balance of nature.

"Michael Becker, Hood River Middle School's Food and Conservation instructor, helped push for a net-zero design for the school's new Music and Science Building. He'd originally examined whether the structure could become a "living building" before recognizing that the school district, which had passed a bond to help fund the structure, likely wouldn't back a self-contained sewage treatment plant. The new structure, which is a net-zero facility, does feature a 14,000-gallon tank that collects rainwater that's used to flush toilets. "I want to turn out a generation of kids who go to college thinking that operating sustainably is normal," Becker said. "At the end of the day, that means more than just going to the recycling bucket." - Andy Giegerich
