



# **Funding Deadlines**

# April 19 - Up To \$11.5 Million Available for Energy Infrastructure Deployment on Tribal Lands

U.S. Dept. of Energy (DOE) funding to deploy energy infrastructure on tribal lands. This funding will support Native American and Alaska Native communities interested in harnessing their vast undeveloped energy resources. This funding opportunity announcement (FOA) builds on efforts to strengthen tribal energy, economic infrastructure resource development, and electrification on tribal lands. This is also the first time that the Office of Indian Energy is issuing a FOA on an entirely fuel- and technology-neutral



basis. This will expand the potential for tribes to use the particular resources available to them and is consistent not only with an all-of-the above energy policy, but also with the principles of tribal sovereignty and self-determination. This funding opportunity will solicit and select applications from Indian Tribes, which include Alaska Native Regional Corporations and Village Corporations, and Tribal Energy Resource Development Organizations in the following areas:

Topic Area 1: Install energy efficiency measures and/or energy generating systems for tribal buildings that may include deep energy retrofits, energy generating systems, or a combination of energy efficiency measures and energy generating systems.

**Topic Area 2:** Deploy community-scale energy generating systems on tribal lands to provide electricity to a substantial number of buildings or even an entire tribal community.

**Topic Area 3:** Install energy systems for autonomous operation to power single or multiple essential tribal loads during emergency situations, or to power a substantial number of essential tribal loads for community resilience.

Selected projects will take on a 50% cost share in order to reduce or stabilize energy costs, as well as increase energy security and resilience for Indian tribes and Alaska Native villages. For additional details, read the "press release and download the <u>full FOA</u>.

# **April 23 - Tribal-Researcher Capacity Building Grants**

NIJ seeks to build an increased capability to conduct rigorous research and evaluation projects in Indian Country and Alaska Native villages through promotion of engagement between researchers and tribal nations. The objective of this solicitation is to fund multiple planning grants for projects promoting such engagements that address criminal justice issues in Indian Country and Alaska Native villages. Proposed projects must include a new tribal-researcher partnership component. Review the solicitation. Applicants must "register with Grants.gov prior to submitting an application.

# April 24 - Tribal Public Health Capacity Building & Quality Improvement Umbrella Cooperative Agreement (CDC)

Center for Disease Control's new 5-year notice of funding opportunity (NOFO), CDC-RFA-OT18-1803: Tribal Public Health Capacity Building and Quality Improvement Umbrella Cooperative Agreement, has been published on Grants.gov. Letters of intent are requested but not required. Letters are due by email attachment to OSTLTSTribalNOFO@cdc.gov by March 30, 2018, by 11:59 pm (EDT). Frequently Asked Questions(https://www.cdc.gov/tribal/cooperative-agreements/faq.html). This program's purpose is to provide resources for American Indian and Alaska Native (AI/AN) tribal nations and regional AI/AN tribally designated organizations to optimize the quality and performance of tribal public health system, including infrastructure, workforce, data and information systems, programs and services, resources and communication, and partnerships. Work in these areas will increase the capacity of Indian Country to identify, respond to, and mitigate public health threats and decrease the burden of disease among AI/Ans. Eligibility: Federally recognized AI/AN tribal nations, which include Native American tribal governments (federally recognized) and AI or AN tribal governments (federally recognized), must demonstrate support from the tribe by providing an official letter from official tribal leaders, or a tribal resolution. Regional AI/AN tribally designated

organizations, which include Native American tribal organizations (other than federally recognized tribal governments), must demonstrate support in the form of tribal resolutions or letters of support from elected and currently serving tribal leadership officials from **at least half** of the tribes within the organization's service area.

# **April 30 - Rural Business Development Grants - RDBGs**

USDA Rural Development grants to support rural businesses and help create jobs. These are NOT direct grants to individuals or businesses. The RBDG allocation for AZ is estimated to be \$300,000 which typically would fund 5-7 grants. Smaller requests are given priority. Grant applications requesting Native American Congressionally mandated funds will be awarded competitively through a national competition. April 30 - 2019 National Urban & Community Forestry Challenge Cost Share Grants
The U.S. Forest Service anticipates approximately \$900,000 in grant funds to be awarded
through the 2019 National Urban and Community Forestry Challenge Cost-Share Grant
Program. The Council seeks to fund proposals that clearly broaden the base of participation
through the involvement of such non-traditional partnerships and the inclusion of underserved
communities with applicable local, state and/or national urban forestry contacts. Underserved
Communities are communities that do not receive equitable financial and technical assistance as
other communities might, in maximizing the benefits from the conservation and management of
their natural resources. In this context we consider underserved as low income, under represented
racial / ethnic minorities; Native Americans; people with disabilities and the elderly. Eligible
Applicants: Any U.S. non-Federal organization and Tribal agencies, operating within the US.
Collaboration with Federal agencies is encouraged. Individuals and private land are not eligible.
Proposals are required to address National or multi-state, multi-tribal land urban and community

# **June 12 - FY18 Choice Neighborhoods Planning Grants**

HUD posted this NOFA to www.grants.gov and is making available up to \$5,000,000 for Planning Grants, including Planning and Action Grants. 1. Planning Grants are two-year grants that assist communities with severely distressed public or HUD-assisted housing in developing a successful neighborhood transformation plan and building the support necessary for that plan to be successfully implemented. 2. Planning and Action Grants are three and a half year planning grants that pair planning with action. Experience shows that tangible actions taken early on help communities build momentum for further planning and the eventual transition from planning to implementation of that plan. These actions improve neighborhood confidence, which in turn sustains the community's energy, attracts more engagement and resources, and helps convince skeptical stakeholders that positive change is possible. Under these grants, the planning process activities would take place during the first 24 months of the grant period. The planning process will identify Action Activities that will be carried out during the latter portion of the grant period. Action Activities must build upon the planning for the target housing and neighborhood. Eligible applicants under this NOFA are: Public Housing Authorities (PHAs); Local governments; Tribal entities; and Nonprofit organizations. # Sept. 30, 2018 - Land Buy Back Program For Tribal Nations (DOI)

Program allows interested individual owners to sell their land for immediate transfer to the recognized tribe that exercises jurisdiction. Effort will strengthen tribal sovereignty and put decision-making in the hands of the tribal government, freeing up resources that have been locked-up as land interests that have fractionated over time. Program will fund indirect costs equal to no more than 15% of the modified total direct costs. \$1.9 billion is available for this 10-year program, which ends in Nov. 2022. Eligibility: Tribes with jurisdiction over locations with purchasable fractional land interests. Broadband Program furnishes loans and loan guarantees to provide funds for the costs of construction, improvement, or acquisition of facilities and equipment needed to provide service at the broadband lending speed in eligible rural areas. ### **Open = Emergency Community Water Assistance Grants (USDA-RD)**

Program helps eligible rural communities recover from or prepare for emergencies that result in a decline in capacity to provide safe, reliable drinking water for households & businesses. Federally recognized Tribal lands and Colonias are eligible; Privately owned wells are not eligible. Up to \$150K for repairs to breaks/leaks in existing water distribution lines, & related maintenance. 
