On Thursday, the United States District Court for the District of Montana, Great Falls Division, heard arguments in *Rosebud Sioux Tribe v. Trump*. NARF was there on behalf of our clients, the Rosebud Sioux Tribe (*Sicangu Lakota Oyate*) and the Fort Belknap Indian Community (Assiniboine (*Nakoda*) and Gros Ventre (*Aaniiih*) Tribes).

At the hearings, the US government argued that the treaties that the United States signed with tribal nations are not relevant to the Keystone XL pipeline. In fact, the treaties were created *specifically* for this sort of violation.

"When the Tribes negotiated their treaties, they gave millions of acres of land to the United States—including, ironically, the land on which the courthouse now stands. In return, they asked that the United States protect their lands from trespass and their resources from destruction. Today, the Presidents of Rosebud Sioux Tribe and Fort Belknap Indian Community were in federal court to invoke their sacred inheritance from these treaties—because the KXL pipeline is exactly the kind of depredation the Tribes sought to prevent," NARF Staff Attorney Natalie Landreth explained after the hearings.

When they entered into treaties with the United States, the tribal nations were working to protect their natural resources (water, grasslands, sacred places, and the great buffalo herds) and keep people from crossing their lands. The United States formally agreed, among other things, to keep outsiders off Lakota (Sioux) and other tribal nations' territories and protect tribal cultural and natural resources. The 2019 pipeline approval violates both of these provisions.

All the Tribes are asking is that the US government honor the treaties that the president signed and the US Congress ratified. All they are asking is the law be upheld. Neither the president nor wealthy foreign corporations are above the laws of our country.

Treaties are not just an agreement between two sovereign governments. Rather, they are an agreement between the citizens of those sovereigns. If a government violates their agreements, they *dishonor* not just themselves, but also the people they are representing.

Do not allow the US government to ignore or forget the agreements made with tribal nations. Don't let this president dishonor our country. Don't allow him to dishonor you. You can support the Tribes' fight for justice.

Silence at the official national level is a squandered opportunity as well as an obvious decision to play things safe politically. One of the signs of a healthy society is its ability to talk about its past in a way that moves people forward from conflict to cooperation.

A collection of statistics from the Nevada Department of Agriculture dating from 1967, the listings of official livestock brands and newsletters from the Nevada Dairy

Mineral County

A collection of newsletters from the Mineral County Nuclear Projects Office, along with county budgets presented to the Department of Taxation.

Mineral Resources in Nevada

Collection contains a directory of mines in Nevada, abandoned mines reports, reports on oil production, a map of major mineral resources, Nevada mineral facts sheets, and a report on the economic impact of changes in federal laws.

• NIMS Alert #31-19: FEMA Seeks Stakeholder Feedback on Trio of Guidance Documents

FEMA (Federal Emergency Management Agency) sent this bulletin at 09/12/2019 11:09 AM

Today, the Federal Emergency Management Agency released for national engagement three documents designed to provide guidance to state, local, tribal and territorial jurisdictions in preparedness as well as response and recovery activities.

The documents on which FEMA is seeking feedback are "Planning Considerations: Disaster Housing," the "Disaster Financial Management Guide" and the "National Incident Management System Basic Guidance for Public Information Officers."

Housing recovery is the cornerstone to a community's resilience. By helping survivors achieve sustainable housing after a disaster, leaders move their communities toward stability and improving resiliency for future incidents. Achieving widespread sustainable housing after a disaster improves a community's ability to recover.

The "Planning Considerations: Disaster Housing" document supplements "Comprehensive Preparedness Guide (CPG) 101: Developing and Maintaining Emergency Operations Plans" by

providing guidance on national housing priorities, types of housing, key considerations, and housing-specific planning recommendations that jurisdictions can apply when developing or improving housing plans. This planning document is a tool for use in conjunction with the Six-Step Planning Process described in CPG 101. The "Disaster Financial Management Guide" is intended to support jurisdictions in establishing and implementing sound disaster financial management practices. The document also presents an overview of common disaster recovery funding programs and resources that may be beneficial to jurisdictions' recovery efforts. The updated document has a broader scope and includes digital engagement and social media protocols as well as provides operational practices to help PIOs perform their duties within the NIMS Command and Coordination structures.

FEMA will host a series of 60-minute engagement webinars to describe the draft document and answer participants' questions about providing feedback. The webinars will be open to the whole community.

FEMA last revised the <u>NIMS Basic Guidance for Public Information Officers</u> in 2007 and is now updating the document to ensure it is consistency, to incorporate stakeholder input, and to make it a clear and useful tool for public information officers as they are involved in emergency management activities.

Effective disaster financial management is critical for successful response and recovery. It helps jurisdictions obtain the resources needed to support their community, increases the efficiency of recovery efforts, and reduces the likelihood of audit failures and financial penalties for the jurisdiction.
