**Just last month, militarized police raided the Wet'suwet'en camps with assault rifles, dogs, sound cannons, and helicopters, while Indigenous elders and youth stood by in shock.**

The assault on the Wet'suwet'en First Nation comes from the Canadian government, in support of fossil fuel giant TC Energy, which is attempting to build a 417-mile fossil fuel pipeline through Indigenous lands -- without the consent of hereditary chiefs. To protect their sovereignty and defend their lands from the pipeline, the Wet'suwet'en First Nation built camps along the pipeline route and have been living there for over 6 years now.

Here in the U.S., we can support the Wet'suwet'en by fighting back against the financial backers of this climate-killing pipeline. We're taking this fight to the doorsteps of the largest banker of and a key investor in the Coastal GasLink pipeline: JPMorgan Chase and Kohlberg Kravis Roberts & Co (KKR).

Indigenous people and allies in Canada have led railway blockades, port shutdowns, sit-ins at government buildings, and huge rallies that have brought Canada to an economic standstill. Students across Canada are holding a nationwide student walkout, and global allies are shutting down Canadian consulates and banks that are funding the pipeline.

The world's biggest banker of fossil fuels, JP Morgan Chase, is helping funnel more than \$5 billion in loans to TC Energy, the company behind Coastal GasLink. And KKR — a New York City-based investment firm with a grotesque reputation for putting profits over employees, people, and the environment — is involved too. It has plans to purchase 65% of the pipeline

with Alberta Investment Management Corp (AIMCo). **But KKR's plans to invest in the pipeline aren't final: There's still time to stop their plans.**

We refuse to let a few billionaires destroy rivers, air, wildlife, and the climate, while hurting people that have endured so much violence already. It's time to get to work. [Are you with us?](#)

This is as much of a fight for Indigenous rights as it is for the future of the planet. The Wet'suwet'en First Nation never signed a treaty to cede their land. Pipeline funders must be held accountable for their role in destroying Indigenous lands and fueling the climate crisis.

This series features footage captured by the U.S. Army Signal Corps as early as 1914, highlighting activities of the Army during World War I. Much of the footage is typical of wartime photography, depicting distant, smoke-filled battlefields and displays of artillery in action. Off the battlefield, however, the cameramen of the Signal Corps focused on individual subjects, capturing intimate moments of smiling officers and shy civilians alike. In the scene below, members of the 53rd Coast Artillery Regiment sit atop a 340 mm railway gun nicknamed “Reveille Kate.”

Comprised of 11 individuals specializing in juvenile justice, social service programs, Indian education, and mental and physical health, the **Alyce Spotted Bear and Walter Soboleff Commission on Native Children, established by Congress, will conduct a comprehensive study of the programs, grants, and supports available for American Indian, Alaska Native, and Native Hawaiian children at government agencies and in Native communities.** They will then issue a report containing recommendations to address the challenges currently facing Native children, with the goal of developing a sustainable system that delivers effective, culturally appropriate, meaningful wraparound services to Native children. The bipartisan Commission is the vision of former U.S. Senator Heidi Heitkamp (D-ND) and U.S. Senator Lisa Murkowski (R-AK) and has a unique and historic opportunity to fundamentally change the trajectory of American Indian, Alaska Native, and Native Hawaiian children for the better.

The Commission will be holding hearings in and reviewing documentation from tribal communities throughout the country to hear from Native children, their families, tribal leaders, and community members. The Commission will also hear from respected researchers and experts as they consider their recommendations. **The first hearing will be March 13-14, 2020 at the Talking Stick Resort in Scottsdale, Arizona.** Members of the public are invited to provide testimony on the afternoon of March 13, and are invited to hear from panels of invited

witnesses on March 14. Interested parties will be given an opportunity to be heard on topics related to the health, education, and well-being of Native children.

The Commissioners are excited to hold their first public hearing. Gloria O'Neill, Chair of the Commission and President/CEO of the Cook Inlet Tribal Council in Anchorage, Alaska, stated, "We are looking forward hearing from the community and experts about how to move the needle on positive outcomes for Native children. We have a great opportunity to make recommendations to the federal government and to get things done to make a difference for our children."

### Use of Technology with Young Children -

Departments of Health and Human Services and Education released a joint policy brief on the use of technology with young children to help families and early educators use technology to promote active, engaged, meaningful, and socially interactive learning. The American Academy of Pediatrics suggest for children younger than 18 months to avoid use of screen media other than video-chatting. Parents of children 18-24 months of age who want to introduce digital media should choose high quality programming, and watch it with their children to help them understand what they're seeing. For children ages 2-5 years, one hour of technology use is appropriate per day, inclusive of time spent at home and in early learning settings and across devices. ### [Clean energy produced on Navajo land could help power Los Angeles](#)

In a city renowned for its green policies, Prius drivers and biodegradable straws, it was only a matter of time before officials would vote to move away from coal powered electricity. To transition to clean energy, the city sold its shares of a coal-powered generating station on the Navajo Nation in 2016, ending a decades-long relationship. What seemed like a bright new sustainable future for Los Angeles presented a harsh reality for the tribe, whose members relied on jobs at the Navajo Generating Station, which shut down completely in November. The generating station near Page contributed \$51 million a year to northern Arizona and southern Utah.
