CoSA's biennial survey of state archives and records management programs in the U.S. is now available!

#### **Download the Report**

This 2021 statistical overview of the state and territorial archives and records management community was drawn from a biennial archives and records management (ARM) survey fielded in 2020. This report confirms the collective commitment of these agencies to the important work of preserving the records of state government, ensuring that they are always available when needed by government and the people.

# The Root Of The Problem

A cluster of ancient eastern bald cypress trees live in North Carolina's Black River wetlands. In 1985, Julie Moore, a retired botanist and former coordinator at the U.S. Fish and Wildlife Service, introduced University of Arkansas professor Dr. David Stahle to the stand in the Black River in southeast North Carolina. A dendrochronologist exploring the relationship between tree growth rings and climate, Stahle began using tree ring mapping and radiocarbon dating on the trees, leading to his discovery of "Methuselah" a bald cypress dating back to 364 AD.

25 years later, Stahle returned to the site, a maze-like waterway navigable only by small watercraft. He went farther into the Black River, and eventually, after coring hundreds of old trees, he identified one singular tree that has been alive since at least 605 BCE, a period of 2,624 years. It's the oldest-known living tree in eastern North America and the fifth-oldest living non-clonal tree species in the world.

This tree has lived in the Black River all this time and survived all kinds of catastrophes. But it <u>won't survive climate change</u>. Currently, there is little more than six feet of elevation standing between the tree and the Atlantic Ocean. Based on estimates that sea levels could rise at least 20 feet in the next 100 to 200 years, this bald cypress could be buried underwater by about 2080. (Guardian)



Drawing on the book's theorizing of an Indigenized environmental justice, this talk covers some of the central themes examined in Professor Gilio-Whitaker's recent publication As Long As Grass Grows: The Indigenous Fight for Environmental Justice from Colonization to Standing Rock (Beacon Press, 2019). It then leans into the author's current work from her forthcoming book to understand what a transformational land ethic looks like.



Mexican American and Latino/a Studies Assistant Professor C.J. Alvarez has spent the last three years studying ... 'desert dwellers' — people who live in the vast 193,000-square-mile Chihuahuan desert that spans states and national borders. He's interested in the unique characteristics that define them and that stretch beyond the political borders of nation states. The Chihuahuan Desert is the biggest desert in North America — about the size of Germany. It encompasses southern New Mexico, West Texas, eastern Chihuahua, and western Coahuila. Despite its large size, Alvarez says many residents of the United States or Mexico would be hard pressed identify it on a map. Historians, too, have often written about deserts from the perspectives of outsiders who saw drylands as either spiritual and artistic places or as harsh wastelands that should be transformed into economically productive spaces through technology and engineering.
