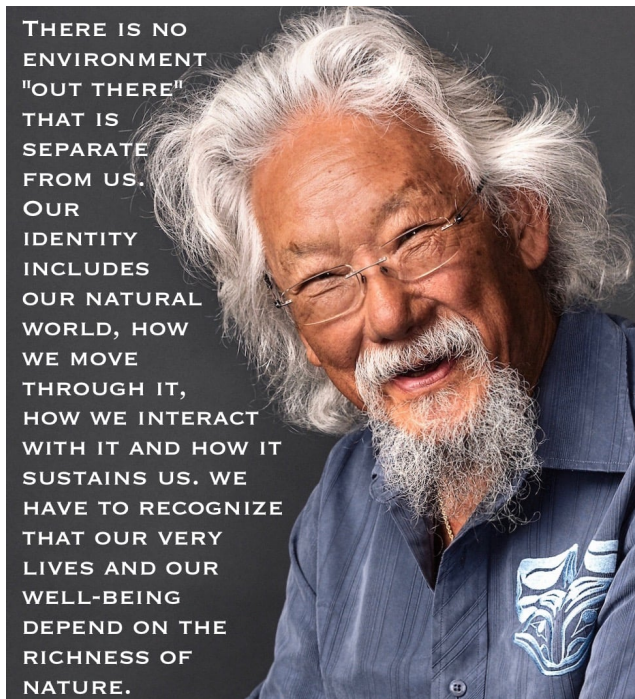

This consultation is being held regarding the implementation of the Indian Boarding School Initiative that Secretary Haaland announced in June 2021. As part of this consultation process, the DOI will be conducting webinar consultations sessions and will request written and oral comments from Tribes and stakeholders until December 23, 2021, to consultation@bia.gov.

NIEA strongly encourages tribal leaders, educators, and community members to submit comments to ensure that DOI is taking the necessary steps in addressing Indian boarding school policies and assist in the effort to recover those histories of Federal Indian boarding schools. Manufacturing or smoking methamphetamine (meth) contaminates residential properties with dangerous and toxic chemical compounds that become airborne and deposit onto walls, ceilings, appliances, floors and carpet, mattresses and any personal possessions exposed. These chemicals pose a health risk to occupants and a potential liability to property owners. AAHA is hosting a two (2) day training on Methamphetamine Decontamination. This training course will cover aspects of meth lab and meth user (smoking) site decontamination/remediation and clean up. Redistricting - Proposed boundaries address dilution of tribal community's voice

(Extract from the Indy). *(This may be moot by "press time")*

Since 2011, the Walker river Paiute Tribe has found its lands and citizens straddled between Senate District 14 and Senate District 17 and Assembly Districts 38 and 39. Though members of the tribe may have shared desires for similar political changes, they cannot approach their state lawmakers as a unified voting block.

But the newly proposed legislative boundaries seek to address the problem

"We just want to be part of one [district]," Schurz Elementary School principal and citizen of the tribe Lance West said [during an October redistricting meeting](#) with state lawmakers. "That way our voice is further empowered and strengthened, rather than split up."

[Proposed legislative boundaries](#) by Democratic leadership place the tribe's land entirely within the proposed Senate District 17 and Assembly District 38, encompassing rural areas outside Carson City. The tribe remains separated on the state's proposed congressional district map.

LARSON R. BILL

August 9, 1948 – November 5, 2021

IN LOVING MEMORY OF LARSON R. BILL

Larson R. Bill, Western Shoshone ("Newe") and beloved husband, brother, father, grandpa, uncle and friend passed on suddenly and unexpectedly from non-COVID related causes on November 5, 2021. Larson was attended in his peaceful passing by family and friends. Larson was born on the Bill Family Ranch (South Fork – "Newe Divyeha") on August 9, 1948 to Percy Bill and Evelyn (Harney) Bill. Larson was the 9th of 12 children. Larson was very proud of his Native American ancestry and was a descendant of the Dosa Wihi'i (White Knife).

Larson was loved by all who met him and had the most unique way of allowing you to laugh while introspecting your own self. While attending meetings at the United Nations, Larson coined the acronym L.A.W.S. – "land, air, water, sun/spirit" – the four sacred elements necessary to sustain life. At the time of his passing, Larson was the President of Great Basin Resource Watch and served over thirty (30) years as an elected official with the Elko and South Fork Band Councils and the Te-Moak Tribe of Western Shoshone as Councilman, Chairman, Vice-Chairman, Board member and community supporter. Larson was instrumental in designing and implementing numerous projects both on and off the reservation including essential bridge and road work, and housing and community buildings; including the Elko Band Gymnasium and the historic Henderson Bank Building. He worked closely with both State and Federal agencies to implement projects and represent his native community in a government-to-government capacity. He served on numerous boards, including the International Roundtable for Mining Assurances (IRMA), the Rural Nevada Development Corporation and as an officer of the Inter-Tribal Council of Nevada. Later in life, Larson acknowledged and advocated for a different approach to the U.S. government to bring all issues to the table with unity of the native people and respect for long-standing Treaty rights in the face of what he referred to as "Corporate America". Larson then became actively involved in indigenous representation at the international level and spoke at forums at the U.S. Congress in Washington D.C. and the United Nations in both New York City and Geneva, Switzerland. In his work, Larson traveled around the world, across the United States and Canada and onto Switzerland, Ireland, Central and South America, Africa and communities in Asia as he advocated for the rights of native peoples to protect and preserve their cultures and traditions in protecting the land, air, water, and sun/spirit (LAWS). He also served as a community organizer for the Western Shoshone Defense Project, an affiliate of the Seventh Generation Fund for Indigenous Peoples (www.7genfund.org). Larson was an adamant believer that "peace and friendship" by the United States begins in their own back yard.

Larson attended school in Lee, Owyhee, and Wells eventually graduating from Elko High School. Larson was an athlete since he was very young, participating in both track and field and basketball and set the record in Wells for running the mile in 4.38 minutes. After high school, Larson was drafted into the Army and served from 1968 to 1971 in the 379th Signal Battalion – Vietnam E-5 as a radio specialist in classified communications during the Vietnam War. After returning from service, Larson went to college for electronics and worked with Bally Distributing and the Xerox Corporation in Reno and Las Vegas. Larson returned to his home in the early 80's to protect his family homestead on the South Fork Indian Reservation and to serve his community. Larson was a jack of all trades and could build, repair or fix anything. He was an avid lover of all things musical and played in a local band as bass guitarist. Larson was always the first to help when asked and went above and beyond helping friends, family and his communities.

As everyone loved Larson, he also loved many in his life and married several times until finally marrying the love of his life, Julie (Horn) Cavanaugh-Bill, on August 8, 2008. Larson had two biological children, Larson Jr. ("Yew-Yews") (deceased) and Jason Bill, with step children, Dawnie Warner Lemley, Julie Belville, and Charli Shabazz. Larson is also survived by nine (9) grandchildren and two (2) great grandchildren.

Larson was preceded in death by both of his parents, siblings Perry Bill, Floyd Bill, Bonnie Treviza, Ruth Campos, Brenda Platerio, Christina Tsosie, Rose Bill and Wayne Bill. He is survived by siblings and in-laws Madeline Bill, Cecilia Bill, Gustavo Vasquez, Wayne Tsosie, Sr. (husband of sister Christina) and Maria Bill (wife of brother Wayne). Larson also had many nieces and nephews who he loved very much.
