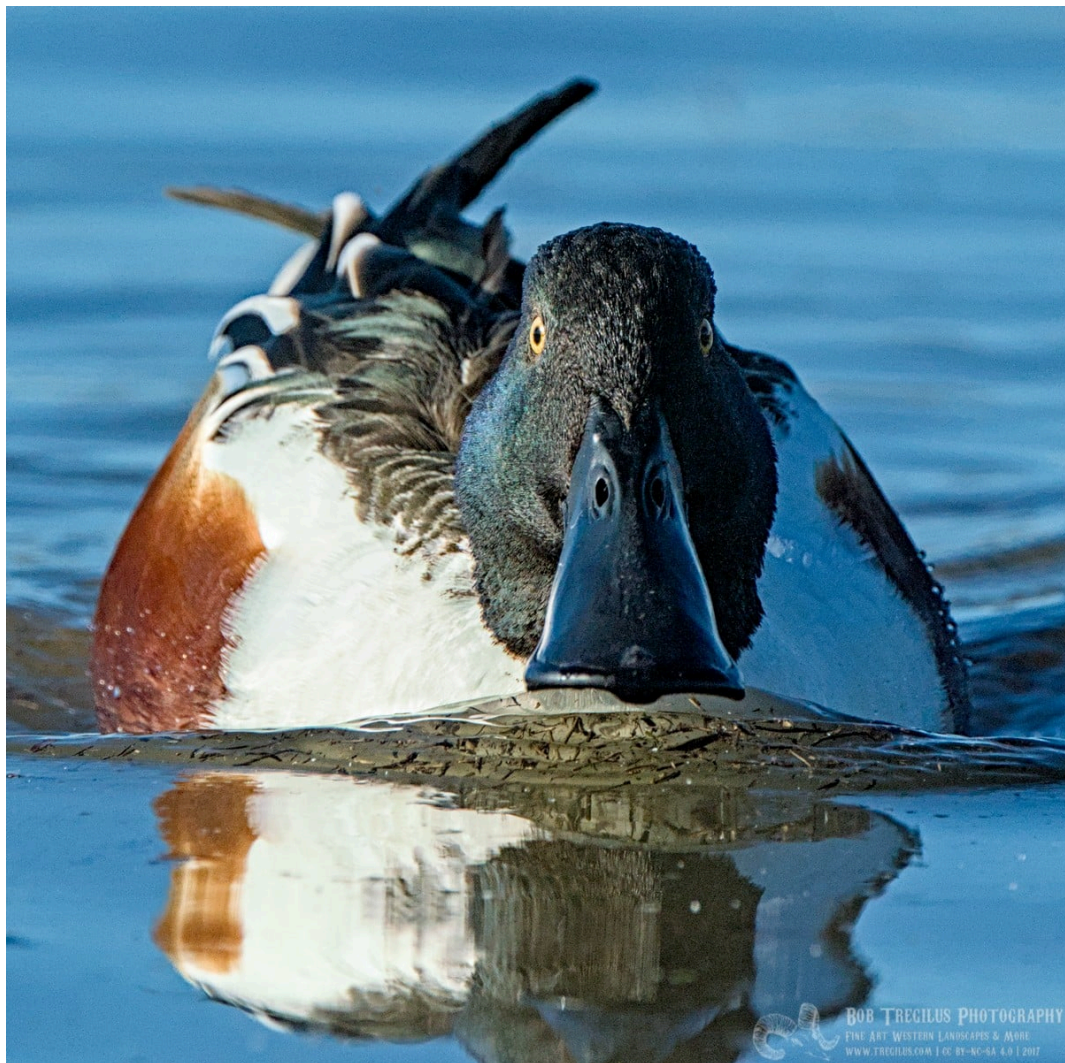

EPA to Hold Science Advisory Board Public Meetings on Cumulative Impact Assessment

The EPA's [Science Advisory Board \(SAB\)](#) will hold a public meeting to consult with EPA regarding how EPA can: (a) use cumulative impact assessment to inform decisions to protect human health and the environment; and (b) conduct research to improve scientific knowledge of cumulative impacts. The public meeting will be held on **March 2, 2022, from 1:00 – 5:00 pm E.T.**

This meeting will be held virtually and is open to the public. EPA invites state, local, tribal, and non-governmental organizations, communities, and other interested stakeholders to participate and provide written or oral public comments for the SAB and EPA on cumulative impacts.

Background:

Cumulative impact assessment is a science-based method of measuring the combined health effects of pollution and social stressors (such as poverty or food insecurity), which can be used to support programs that improve community health and well-being. Cumulative impact

assessments will help EPA advance its environmental justice goals by reducing pollution in overburdened communities throughout the United States. The SAB will give EPA advice on how to use cumulative impact assessments in short-term decision-making processes, and will review a draft of EPA's report entitled "[Cumulative Impacts: Research Context and Recommendations](#)". This report will inform EPA's future research on cumulative impacts. Following the consultation and public comment period, the draft will be revised and finalized.

The SAB is a federal advisory committee that provides independent, expert advice to the EPA Administrator on a range of environmental science, engineering, environmental justice, and economic issues.

**Indian Housing Block Grant Competitive Program Feedback Requested by March 20, 2022**

Dear Tribal Leader:

As you know, there is a dire need to increase affordable housing in Indian Country. According to the U.S. Department of Housing and Urban Development's (HUD's) 2017 Housing Needs Study, approximately 68,000 new units are needed to eliminate overcrowding and replace inadequate dilapidated homes. Although Tribes and Tribally Designated Housing Entities have worked hard to stretch their Indian Housing Block Grant (IHBG) formula grant funds year after year, the development of new housing remains a challenge. To help address this concern, since fiscal year 2018, the Congress has appropriated \$100million annually for IHBG Competitive grants. In addition, the Congress has directed HUD to prioritize both new construction and rehabilitation projects when awarding these grant funds.

Having now administered three separate IHBG competitions, HUD is interested in your feedback on how the program has been working and what changes could be made to improve it in the future. The goal is to ensure that HUD is always making improvements to the Notice of Funding Opportunity process, distributing funding in an equitable manner, and funding projects that will have a major impact on Tribal communities and make the lives of Native American families better. With this in mind, HUD is requesting your feedback on the following questions:

1. What has been your experience when applying for an IHBG Competitive grant?
2. What challenges have you faced with the IHBG Competitive grant program?
3. Do you believe HUD has administered the IHBG competition fairly and equitably?
4. What changes could HUD make to future competitions to help address your concerns?
5. Do you have any other recommendations or feedback on the IHBG Competitive grant program?

Comments should be submitted electronically to [Codetalk@hud.gov](mailto:Codetalk@hud.gov) by March 20, 2022. HUD will share any feedback received with the House and Senate Appropriations Committees to ensure that Congress is aware of the views of Tribal stakeholders and to help inform any future legislation with respect to the IHBG Competitive grant program. Your feedback is critical and your continued commitment to Indian Country is vital to our collective efforts to ensure that Native American families have decent, safe, and affordable housing. This [Dear Tribal Leader](#) letter informs Tribes and Tribally Designated Housing Entities (TDHE) of their Indian Housing Block Grant (IHBG) formula allocation estimate for Fiscal Year (FY) 2022 and transmits the forms required for correcting the FY 2022 IHBG formula data and the FY 2023 IHBG Needs data. In the past, the U.S. Dept. of Housing and Urban Development (HUD) would mail this information. However, due to the COVID-19 pandemic, HUD has posted following information on-line at: <https://ihbgformula.com/fy2022/>. **REMINDER!** Census Challenges for the FY 2023 IHBG Needs data must be submitted no later than **March 30, 2022**, for consideration for the FY 2023 IHBG formula allocation estimates.

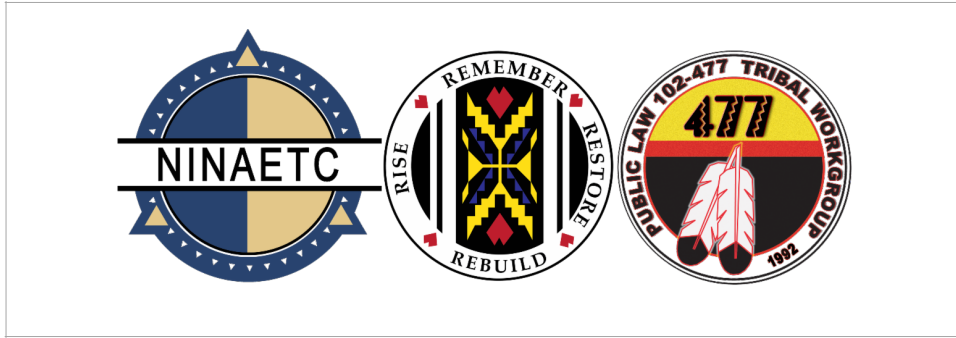
## **Tribal Climate Resilience and Adaptation**

## **[SAM.gov](#) - 60-Day Extensions for Entity Registration Renewals During Transition to the New Unique Entity ID**

Starting Monday, April 4, 2022, the new Unique Entity ID (generated in [SAM.gov](#)) will be the official, governmentwide identifier used for federal awards. To reduce burden during the transition, there will be an automatic, 60-day extension for any existing [SAM.gov](#) entity registration needing to renew with an expiration date ranging between March 18, 2022, and April 18, 2022. No action is required on the part of entity registrants. Each impacted registration renewal will have 60 days added to their expiration date. As an example, an entity registration set to expire on March 18, 2022 will automatically be granted a 60-day extension to May 17, 2022. Entity administrators impacted by this change will receive an email from [samadmin@sam.gov](mailto:samadmin@sam.gov) with the subject line "60-Day [SAM.gov](#) Extension Granted for [Entity Name/DUNS/CAGE]." The new expiration dates will be included in the SAM entity management extracts and available through web services after the records are extended. Extensions will be processed by March 3, 2022.
