SAM.gov - 60-Day Extensions for Entity Registration Renewals During Transition to the New Unique Entity ID

Starting **Monday, April 4, 2022**, the new Unique Entity ID (generated in SAM.gov) will be the official, governmentwide identifier used for federal awards. To reduce burden during the transition, there will be an automatic, 60-day extension for any existing SAM.gov entity registration needing to renew with an expiration date ranging between March 18, 2022, and April 18, 2022. No action is required on the part of entity registrants. Each impacted registration renewal will have 60 days added to their expiration date. As an example, an entity registration set to expire on March 18, 2022 will automatically be granted a 60-day extension to May 17, 2022. Entity administrators impacted by this change will receive an email from samadmin@sam.gov with the subject line “60-Day SAM.gov Extension Granted for [Entity Name/DUNS/CAGE].” The new expiration dates will be included in the SAM entity management extracts and available through web services after the records are extended. Extensions will be processed by March 3, 2022. If you need assistance with any of the IAE systems, including SAM.gov, contact the Federal Service Desk at www.FSD.gov . For eLOCCS users: By April 4, 2022, the Government will transition away from using the Dun & Bradstreet data universal numbering system (DUNS) to the new Government issued Unique Entity Identifier (UEI) as a means of entity identification for federal awards. Entities must be registered in SAM.gov to qualify for federal awards, which are reported to the public through USASpending.GOV. If you have not already registered or your registration has expired, please register immediately at <https://sam.gov/content/duns-uei> This is a link to the GSA SAM web site which contains a number of resources related to the UEI implementation. One of the state's newest electric-vehicle charging stations is located in Primm. (NV Energy)

Nevada stands to get \$38 million over five years to build out electric-vehicle (EV) charging networks from the Biden administration's newly released EV funding plan, part of the [Infrastructure Investment and Jobs Act](#).

The Department of Motor Vehicles said Nevada now has [more than 17,000](#) registered electric vehicles.

Marie Steele, vice president for electrification and energy services at NV Energy, said its customer surveys predict a big jump in the years to come.

"Twenty-five percent of our customers say that their next vehicle will be electric and another 25% are neutral," Steele reported. "Certainly the number is growing, and we're anticipating that more is going to be online soon."

She added Nevada's Electric Highway program is well on its way to placing an EV charging station every 50 miles, especially on I-15 and I-80. And NV Energy is offering a \$2,500 rebate to help low-income families buy an electric vehicle.

Christi Cabrera, policy and advocacy director for the Nevada Conservation League, noted Nevada's new vehicle emissions standards will go into effect in 2025.

"Last October, we passed the clean-car standards," Cabrera recounted. "Nevada will be getting more electric vehicles on our lots."

By statute, Nevada must prioritize low-income areas, rural areas and tribal lands when placing new EV charging stations.

Larissa Koehler, senior energy attorney for the Environmental Defense Fund, said those communities will also benefit as more zero-emissions trucks and buses hit the road.

"It'll be critically important, most notably in disadvantaged communities that are really disproportionately impacted by truck and bus pollution, to make sure that we're prioritizing those communities and making sure that the benefits of electric vehicles are seen," Koehler remarked.

A [recent analysis](#) from the Environmental Defense Fund found we could prevent 57,000

premature deaths nationwide and eliminate 4.7 billion metric tons of pollution by 2050, if we switch over to zero-emission freight trucks and buses by 2040 in urban areas, and by 2035 in urban and community areas.

The project must be of significant benefit to the preservation field, such as work on a book, long article, or key speech/presentation on the future of preservation, and concerning matters of importance including social justice, diversity and inclusion, housing, equitable development, climate action, re-imagining historic sites, preservation trades and workforce development, telling a fuller history, or another topic of key importance to the preservation field today.

Special attention will be given to projects that notably advance one or more of the seven goals surfaced through the [National Impact Agenda: Leading the Change Together](#).

In addition to lodging, Rockefeller Brothers Fund will provide approximately \$125/week for food. In addition, transportation to and from NYC will be covered, while the National Trust will fund other reasonable domestic transportation costs. International travel will not be reimbursed.
