

1831: The Supreme Court failed to enforce treaties that would have protected the Cherokee people from state and federal interference and from forcible removal later that year. Beginning in 1827, the State of Georgia enacted legislation that nullified Cherokee laws and appropriated Cherokee lands. In response to Georgia's extension of its law over the Cherokee Nation, the Cherokee filed suit in the U.S. Supreme Court, challenging the legislation and citing treaties the nation had previously entered into with the U.S. government. The Cherokee argued that those treaties established the Cherokee Nation as a sovereign and independent state. Ultimately, SCOTUS joined the other branches of U.S. government in refusing to honor their own treaties. (Which, of course, was the plan from Day One.)

To overcome racial inequality, we must confront our history.

Last week HUD published a Request for Information (RFI) in the Federal Register regarding the Fiscal Year 2023 Learning Agenda Supplement.

HUD's Office of Policy Development and Research (PD&R) seeks public input regarding potential additions and adjustments to the Department's published Learning Agenda to reflect changes in learning priorities since March 2022.

Information provided in response to this RFI will inform the development of the "Learning Agenda Supplement: Fiscal Year 2023" that HUD will publish to accompany the 2022–2026 Learning Agenda to document updates to the Department's priority learning needs.

#### **Rochester Museum & Science Center**

According to oral tradition, nearly 1,000 years ago along a wooded ridge east of Lewiston, NY at Fort Kienuka, Jikonsaseh (also spelled Jigönsahse') held the role of Neutral Nation woman leader.

Her leadership held the potential to create war with one decision, and she accepted a message of peace from a visiting Peacemaker.

As the first to accept this message and one who bravely faced the formidable Onondaga leader, Tadodaho, her decision helped to unite the original five nations of the Haudenosaunee Confederacy (Seneca, Cayuga, Onondaga, Oneida, and Mohawk; Tuscarora later joined as the sixth nation), bringing peace and stability.

She later became known as the "Mother of Nations" and was given deciding power of chiefs' and clan mothers' roles within the Confederacy. Clan mothers hold a great role as leaders and have the ability to choose the chiefs, give babies their names, and decide whether or not to go to war among many other essential responsibilities.

Haudenosaunee traditions continue to uphold these practices today and respect women as leaders in a matrilineal society.

### **Stewart Indian School**

We are heartbroken to tell you that Buck Sampson has passed. Floyd "Buck" Sampson, Northern Paiute, was born and raised in Reno, NV. He attended Stewart Indian School from 1968 to 1971. While at Stewart, Buck was on the boxing team and played baseball. His favorite subject was American Indian history, because he "liked to argue with the teacher that the history textbooks were wrong." He said he was amazed by how many tribes were represented and it made "him feel proud to be an Indian." His grandfather Dewey Sampson and Dewey's older brother Harry attended Stewart as well as other family members. Upon graduation Buck received three scholarships (boxing, English and American Indian history) to the University of Nevada, Reno. Buck continued boxing after Stewart and was a youth boxing coach for two decades. After retiring from the City of Reno, Buck helped in the preservation of the Stewart Indian School as Chairman of Nevada Indian Commission's Stewart Advisory Committee. Buck was always willing to share his Stewart story with others and attended many Stewart related events including numerous Stewart Father's Day Powwows. Buck will be deeply missed by many, but his story will continue to live on in the Stewart Indian School & Museum's archives and permanent exhibit.
