Hoopa Valley Tribe, California partner on first-ever broadband co-build, signaling a potential paradigm shift



More than a quarter of California's households lack internet access, per a report from the California Public Utilities Commission published in 2021. Many of those households are Native people located in rural areas where middle-mile fiber is expensive because of geographic and infrastructure challenges. The Hoopa Tribe in northern California believes it can make broadband more accessible and affordable throughout the region thanks to a new partnership that could be a model for other tribes. Fresh off of a \$65 million cash infusion by the National Telecommunications and Information Administration (NTIA) Tribal Broadband Connectivity Program Grant, the Hoopa Tribe has partnered with the state of California to jointly build 23 miles of fiber construction on Hoopa tribal lands. The state is effectively paying \$10.25 million toward the build, expanding the buildout already under way, according to Hoopa Valley Public Utilities District General Manager Linnea Jackson. The agreement came about through collaborative work by the California Department of Technology, the Hoopa Valley Public Utilities District (HVPUD), and the Corporation for Education Network Initiatives in California's Golden State Network program. It's the first such partnership in the country, and hopefully the start of a paradigm shift in how states see Native American internet providers, Jackson told Tribal Business News. The partnership itself could ripple out into other areas of state-tribe relationships, in particular with the Broadband, Equity, Access, and Deployment (BEAD) program, which the NTIA rolled out this summer. That program delivered \$42.5 billion to all 50 states, leaving each state to further distribute the money into subgrants for broadband infrastructure development

Justice Department Announces Funding Opportunities to Support Public Safety in TribalCommunitiesWASHINGTON – The Justice Department today announced the opening of the 2024Coordinated Tribal Assistance Solicitation (CTAS) period for comprehensive funding to American Indianand Alaska Native Tribes. CTAS funding supports crime prevention activities, victim services andcoordinated community responses to violence in Indian Country.

Administered by the department's Office of Justice Programs (OJP) and Office of Community Oriented Policing Services (COPS), the solicitation includes guidance on how federally recognized Tribal governments and Tribal consortia can apply for funding to aid in the development of a comprehensive and coordinated approach to public safety and victimization.

"The Office of Justice Programs is committed to working with Tribes and Tribal communities to provide a wide array of services and supports to help keep their communities safe," said Assistant Attorney General Amy L. Solomon of OJP. "Our grants provide funding to Tribes for their juvenile justice and criminal justice systems, including providing support to victims and families, helping to strengthen Tribal court systems and enabling tribes to develop, expand or strengthen approaches along the juvenile justice continuum."

The funding from OJP's Bureau of Justice Assistance, Office of Juvenile Justice and Delinquency Prevention and Office for Victims of Crime, along with funding from the COPS Office, can be used for a range of public safety and justice-related projects and services. These include enhancing law enforcement, advancing fair and effective adult and juvenile justice systems and reducing juvenile delinquency and improving youth outcomes. In addition, the grants serve American Indian and Alaska Native victims of child abuse, sexual assault, domestic violence and elder abuse.

"The COPS Office is well aware of the vital role Tribal law enforcement plays in ensuring the safety and well-being of our Native American communities," said Director Hugh T. Clements Jr. of the COPS Office. "Our commitment to providing them with the resources they need — including officers, equipment and training — is unwavering. By investing in the capabilities of Tribal law enforcement, we strengthen the fabric of justice that spans across state, local, Tribal, and territorial jurisdictions."

In FY 2023, the department awarded 182 CTAS grants, amounting to more than \$96 million in CTAS funding to 111 Tribes and Tribal consortia across the United States.

The <u>grants.gov</u> application deadline for CTAS is March 5, 2024, at 8:59 p.m. ET, and the JustGrants deadline is March 12, 2024, at 8:59 p.m. ET.

The department will also facilitate a series of webinars to guide applicants through the application process. Details, including how to register for these webinars, will be made available online in the coming weeks <u>here</u>.

New Deadline for Submitting FY 2024 IHBG Formula Interim Funding Requests in the GEMS

ONAP is currently accepting IHBG Formula interim funding requests via GEMS through **January 5, 2024**. This deadline ensures that awards will be processed prior to the January 19, 2023, expiration of the Continuing Resolution (CR) under which HUD is currently operating. Interim funding requests should be submitted in GEMS. Please refer to the <u>GEMS Grantee</u> <u>Guide</u> for specific instructions on completing and submitting the request. This guide and other GEMS resources can be found at the <u>GEMS webpage</u>.

Interim funding is an advance on IHBG formula funds while under a CR. Grantees with a low balance of IHBG funds can request a partial award to maintain housing operations until a

federal budget for FY 2024 is passed by Congress. A request for interim funding may only be granted if your FY 2024 Indian Housing Plan has been found in compliance and approved and if you have a low balance in LOCCS. HUD Deploys Funding Navigator to Connect Program Participants, including Tribes and TDHEs, to Billions of Dollars in Federal Funding and Tax Credits to Improve Carbon Reduction and Climate Resilience.

HUD deployed the **Funding Navigator**, an interactive tool that allows the user to browse and sort funding opportunities for billions of dollars in funding available under the Inflation Reduction Act (IRA) and Bipartisan Infrastructure Law (BIL). Tribes and TDHEs will be able to focus their search for funding available to federally recognized Tribes. In addition, Tribes can find existing technical assistance resources for climate resiliency, energy efficiency, renewable energy, and environmental justice at <u>Build for The Future</u> and <u>ONAP's Tribal Climate Resilience and</u> <u>Adaptation</u>. The White House released an <u>updated technical assistance guide</u> that focuses on federal and state technical assistance programs aimed at accessing and deploying Bipartisan Infrastructure Law and Inflation Reduction Act funding. This new guide highlights programs that help communities navigate programs and resources that can help them deliver infrastructure, clean energy, and climate resilience projects.

NEW DOE Offers Tribes \$225 Million in Rebates for Home Electrification and Appliances

The U.S. Department of Energy has released application guidelines for tribal governments to apply for \$225 million in funding under the Inflation Reduction Act's Home Electrification and Appliance Rebate (HEAR) program. HEAR funds will provide rebates to low- and moderate-income households installing efficient electric technologies. Rebates for home electrification upgrades range from \$840 to \$14,000 per household. Rebate amounts vary depending on a household's income, the total project cost, and the technologies installed. Multifamily and single-family buildings, including manufactured housing, may be eligible for rebates. Eligible households may be owner-occupied or rented. Once DOE has approved a tribe's HEAR application, the tribe may launch its program and begin issuing rebates. Tribal officials can review the published guidance in DOE's new Administrative and Legal Requirements Document.

DOE has also released the <u>final funding amounts</u> individual tribes will receive after DOE approves their applications, as well as an <u>explanation of how it allocated the funds</u>. Tribal

- December 20 In 1950 the Nevada State Journal claimed "While Indians around Pyramid Lake continue battle to retain tribal lands against infringement by white settlers, BIA is prepareing to sell large amount of Indian land in California and nobody is objecting."
- December 21 In 1932 newspaper reported that atty George Thatcher explaining the Wingfield bank failures, answered questions in part with sentence,"If that happens, we might as well give the country back to the Indians" and later learned that his questioner was Native American.
