Today is the International Day of Democracy, recognized annually around the world after passing the United Nations General Assembly almost 20 years ago.

As the United Nations writes: *"The International Day of Democracy provides an opportunity to review the state of democracy in the world," defining democracy as "a universal value based on the freely-expressed will of people to determine their own political, economic, social and cultural systems, and their full participation in all aspects of life."*

Native peoples understand democracy, with generations of experience collectively self-governing our lands and communities. Here at Native Organizing Alliance, when we talk about the importance of achieving sovereignty and treaty rights for Natives in the United States, we're really talking about building a much more deeply multi-racial democratic political system where everyone can participate in the decisions that impact our lives.

**This election year, we're engaging more Native people in the political process to create better conditions for all marginalized groups to be heard.** We're not only protecting Native voting rights, but joining with all those who are being denied the right to vote. Only by standing together will we overcome racist voter suppression.

Native Organizers Alliance is an ecosystem of Tribal leaders, traditional societies, and grassroots community organizers who are working for self-determination. We partner with grassroots Native-led campaigns across Turtle Island, and every year we train hundreds of Native leaders to sharpen their grassroots community-building.

**During election years, we also mobilize the Native vote to help protect democracy for all.** Natives peoples' right to vote is connected to our inherent sovereignty: our right to make decisions for our lands and our communities.

Our movement helped turn out the Native vote in record numbers in 2020 and following elections, which has meant not only that we've elected more Natives to office, but also that more elected officials from all backgrounds are listening to Native communities and seeing us as politically significant.

Unfortunately there's been a backlash to this progress, with right-wing state lawmakers and judges attacking and suppressing voting rights at record speed -- on top of the discriminatory barriers we already face when voting, like the fact many states require a residential address for voter registration. This poses a significant barrier for Native peoples, especially those living on Tribal lands or in rural areas where many homes do not have physical mailing addresses.

So we're doubling the number of "moccasins on the ground" for 2024's elections, growing our Natives Vote Campaign to register and turn out our communities. Focusing on 12 target states with high Native populations, we're coordinating with Tribal leaders and Native community groups to train 200 Organizing Fellows and help ensure Native peoples can exercise their right to vote.

Engaging communities in the political process is year-round, so these Organizing Fellows will continue working with their Tribes and community groups beyond the 2024 elections. Together, we're helping build grassroots movements for Native self-determination and political power -- an essential part of expanding the United States' tattered democracy to ensure it works for all people

WASHINGTON, Sunday, April 16.

Yesterday morning Attorney-General SPEED waited upon Hon. ANDREW JOHNSON, Vice-President of the United States, and officially informed him of the sudden and unexpected decease of President LINCOLN, and stated that an early hour might be appointed for the inauguration of his successor. The following is a copy of the communication referred to:

After the presentation of the above letter, the Chief Justice administered the following oath to Mr. JOHNSON:

"I do solemnly swear that I will faithfully execute the office of President of the United States, and will, to the best of my ability, preserve, protect and defend the Constitution of the United States."

After receiving the oath, and being declared President of the United States, Mr. JOHNSON remarked:

"Gentlemen, I must be permitted, to say that I have been almost overwhelmed by the announcement of the sad event which has so recently occurred. I feel incompetent to perform duties so important and responsible as those which have been so unexpectedly thrown upon me. As to an indication of any policy which may be presented by me in the administration of the government. I have to say that that must be left for development as the Administration progresses. The message or declaration must be made by the acts as they transpire. The only assurance that I can now give of the future is by reference to the past. The course which I have taken in the past in connection with this rebellion, must be regarded as a guarantee of the future. My past public life, which has been long and laborious, has been founded as I, in good conscience believe, upon a great principle of right, which lies at the basis of all things. The best energies of my life have been spent in endeavoring to establish and perpetuate the principles of free government, and I believe that the government, in passing through its present trials, will settle down upon principles consonant with popular rights, more permanent and enduring than heretofore. I must be permitted to say, if I understand the feelings of my own heart, I have long labored to ameliorate and alleviate the condition of the great mass of the American people. Toil and an honest advocacy of the great principles of free government have been my lot. The duties have been mine -- the consequences are God's. This has been the foundation of my political creed. I feel that in the end the government will triumph, and that these great principles will be permanently established. In conclusion, gentlemen, let me say that I want your encouragement and countenance. I shall ask and rely upon you and others in carrying the government through its present perils. I feel in making this request that it will be heartily responded to by you and all other patriots and lovers of the rights and interests of a free people."

At the conclusion of the above remarks, the President received the kind wishes of the friends by whom he was surrounded.

A few moments were devoted to conversation. All were deeply impressed with the solemnity of the occasion, and the recent sad occurrence that caused the necessity for the speedy inauguration of the President was gravely discussed.

Mr. JOHNSON is in fine health and has an earnest sense of the important trust that has been confided in him.

WM. HUNTER, Esq., the Chief Clerk of the State Department, has been appointed Acting Secretary of State.

A special meeting of the Cabinet was held at the Treasury Department, at 10 o'clock this morning.
