Among all U.S. presidents, Trump has issued the 15th-most executive orders with 318 orders across his two terms in office. Franklin D. Roosevelt (D) issued the most of all U.S. presidents with a total of 3,721 executive orders during his time in office. William Henry Harrison (Whig) issued the fewest, having issued none during his one month in office. Three presidents issued only one executive order each: James Madison (Democratic-Republican), James Monroe (Democratic-Republican), and John Adams (Federalist).

This EO came out; however, there has been a lot of concern this week after an announcement that almost the entire DOL's DINAP team including the Division Chief is accepting the buyout and leaving federal service, with the exception of 4 and that includes one who has been placed on administrative leave. My most seasoned former colleagues including the supervisory manager will be gone by Friday, leaving only 3 fairly new hires. And one that has been placed on leave.

I also heard that all my equivalent former colleagues (Division Chiefs) of the nationally administered programs have also accepted the buyout and are leaving as well as some of the staff.

Not sure what this means for those programs but it sounds like the Administration is looking to consolidate or eventually eliminate those programs. Some recent press articles resulted in the dismissal of DOL's Assistant Secretary after press releases were made regarding the employee's that were placed on leave. They didn't mention Indian Programs but the one native staff they placed on leave was instrumental in designing the reporting system and had also been helping other programs. DOGE came in and took over the Office of Information Technology.
