

#### President Rutherford's Fourth State of the Union Address 6 Decmber 1889

This is the first SOU not to have any mention of Indian Affairs. It, as all SOUs, provides a fascinating snapshot of perspectives of the time. This address focuses on Polygamy, civil service reform, resistance fo implementation of the 15th Amendment, and an extensive rundown of relations with countries around the world. Hays suggests a underground cable across the Pacific, bolstering maritime trade, and is specifically fiscally aware: *"The only road, the sure road to unquestioned credit and a sound financial condition is the exact and punctual fulfilment of every pecuniary obligation, public and private, according to its letter and spirit."* 

His address ends succinctly:

The condition of the financial affairs of the Government, as shown by the report of the Secretary of the Treasury, is very satisfactory. It is believed that the present financial situation of the United States, whether considered with respect to trade, currency, credit, growing wealth, or the extent and variety of our resources, is more favorable than that of any other country of our time, and has never been surpassed by that of any country at any period of its history. All our industries are thriving; the rate of interest is low; new railroads are being constructed; a vast immigration is increasing our population, capital, and labor; new enterprises in great number are in progress, and our commercial relations with other countries are improving.

The ordinary revenues from all sources for the fiscal year ended June 30, 1880, were— From customs - \$186,522,064.60 From internal revenue - 124,009,373.92 From sales of public lands - 1,016,506.60 From tax on circulation and deposits of national banks - 7,014,971.44 From repayment of interest by Pacific Railway companies - 1,707,367.18 From sinking fund for Pacific Railway companies - 786,621.22 From customs fees, fines, penalties, etc - 1,148,800.16 From fees-consular, letters patent, and lands - 2,337,029.00 From proceeds of sales of Government property - 282,616.50 From profits on coinage, etc - 2,792,186.78 From revenues of the District of Columbia - 1,809,469.70 From miscellaneous sources - 4,099,603.88

#### **History Bits**

- **1774 Apr 30** Virginia colonists murdered an entire nine member family of **Mingo chief Thagahjute (baptized Logan)**, precipitating Lord Dunsmore's War and provokingLogan's vengence killing of more than a dozen.
- **1849 May 3** Residents of "Eastern California" request Congress to charter a territorial government of the most liberal construction, to be known as "Deseret".
- **1866 Apr 28** A peace and friendship treaty signed between USA and Choctaw and Chickasaw; tribes agreed to give up their African American slaves (after the civil war, some tribes refused to release their slaves so their freedom had to be negotiated by treaty.)
- **1871 Apr 30** At an Arivapa Apache camp, 110 women/children and 8 men were killed and 28 infants kidnapped by 150 Anglo and Mexican Arizonans led by William Oury, a survivor of the Alamo who has a mountain in Texas named for him.
- **1874 Apr 28** Word reached Nevada that the U.S Senate had approved (\$19,000 to pay a John McPeak for supplies furnished to volunteers for attack on Native Americans fourteen years earlier.
- **1886 May 3** President Cleveland reserved additional land to the Western Shoshone, expanding the size of the Duck Valley Indian Reservation.
- **1888 Apr 27** Nevada officials were surprised by a check from the U.S. government for \$23,180.92 (approx \$965,057 today) in partial payment for money staqte spend in outfitting soldiers for Civil War and lager battles with Indians in Elko and White Pine Counties.
- **1926 Apr 30** At the Walker River Confab, U.S Congressman Arentz (self-described as repping ag water users) called DOJ and BIA to speed settlement of suit filed by US Atty Springmeyer on behalf of the tribe (tribe apparently not permitted to represent itself at the conference).
- **1942 Apr 28** Two weeks after the Scy of the Navy chose Lake Tahoe as the site of a wartime naval training facility, Senator Patrick McCarran (whose dearest wish was to break up the Res) convinced Admiral Benjamin Morrell to study Pyramid Lake as the site.
- **1966 Apr 27** President Lyndon Johnson signed legislation to promote recreation development at Pyramid Lake.
- **2001 Apr 29** California's **Maidu Museum** opened on a 30 acre site that was once a Maidu tribal village and still has petroglyphs.
- **2007 May 2** Western Shoshone representatives attended Barrick's annual stockholders meeting in Toronto to relate their opposition to the mine and call on Barrick to make a good faith effort to resolve the issue.

# BIA proposes consultation in response to Executive Order (EO) 14210

Dear Tribal Leader:

As we navigate the complexities of our nation's fiscal realities, President Trump and his Administration are working to enhance government efficiency while upholding trust and treaty obligations across Indian Country. Our objective is to streamline operations while minimizing any potential impact on the quality of services provided to Tribes. To that end, Indian Affairs -which includes the Bureau of Indian Affairs (BIA), the Bureau of Indian Education (BIE), the Bureau of Trust Funds Administration (BTFA), and the Office of the Assistant Secretary-Indian Affairs- seeks to engage directly with federally recognized Tribes to receive formal input on critical needs as we develop plans to implement operational improvements. Indian Affairs and other agencies within the U.S. Department of the Interior (Department) remain committed to fulfilling our responsibilities efficiently and effectively.

On February 11, 2025, President Trump issued an **Executive Order (EO) 14210** establishing the "Department of Government Efficiency" Workforce Optimization Initiative, which aims to reform the Federal workforce to maximize efficiency and productivity. Under this directive, each agency is required to develop an Agency Reorganization Plan. In support of this effort, the Department is committed to receiving formal consultation feedback from Tribes regarding the EO and related topics, including:

• Restructuring of Indian Affairs to support more efficient interactions with Tribes: In 2013, after a third-party review and extensive consultation, Indian Affairs implemented significant changes to the structure of the agency and how the agency interacts with Tribes. Indian Affairs remains committed to those efforts as well as the efforts of EO 14210 to be more efficient without diminishing the current levels of operational support and services to Tribes.

# What recommendations would you make to Indian Affairs to improve efficiency through staffing changes, resource sharing, process improvements, and potential consolidation of programs and offices?

• Addressing current funding structures, including identifying efficiency barriers to expedite funding to Tribes and Tribal programs:

Indian Affairs understands that the funding structures and mechanisms for Tribal programs are complicated and include a combination of Tribal Priority Allocations, one-time awards, grant funding, formula funding, and other Federal funding sources. What recommendations would you make to Indian Affairs to improve access to Federal programs, funding, and services?Indian Affairs is seeking input on how to better support Tribes by reducing the administrative burden to access and administer funding, improving communications with Tribes on funding opportunities, and improving technical assistance and direct support to Tribes to obtain and administer funding.

• Increasing Indian Affairs support for Tribal self-governance and self-determination:

The Indian Self-Determination and Education Assistance Act (ISDEAA; P.L. 93-638, 25 U.S.C. §§ 5301 et seq.) outlined federal policy on Tribal self-determination . Since the ISDEAA enactment, Congress has authorized the expansion of Tribal self-determination and self-governance across the Federal Government.

How can Indian Affairs optimize its functionality and effectiveness to provide Tribes with improved flexibility to foster economic growth, address the specific local needs of their communities, and increase pathways to self-determination and self-governance?

The Department will conduct six (6) in-person/hybrid and one (1) virtual Tribal consultation sessions to accept oral and written comments. Please note the Tribal consultation sessions will be closed to the press and the public to protect any confidential information that may be discussed during the formal consultation sessions.

The Department will also conduct one (1) virtual consultation session for interested parties of the BIE to provide oral and written comments. Parties include but are not limited to: students emolled at BIE-funded schools, parents of such students, school administrators, school board members, and the Indian communities served by BIE-funded schools. Please note the BIB-specific consultation session will also be closed to the press to protect any confidential information that may be discussed during the formal consultation sessions. Sincerely,

Today, Walker River Paiute Tribe citizen and former Chairwoman Andrea Martinez stood before the Assembly Committee on Legislative Operations and Elections to speak in support of SB421.

In her testimony, Andrea reminded the committee that Native voices have too often been silenced by systemic barriers to the ballot box. SB421 would require election officials to staff polling places on reservations—unless a tribe declines—honoring tribal sovereignty while protecting the fundamental right to vote.

This moment matters. Voting is more than a right—it's a declaration of identity, selfdetermination, and the future we choose for our people. When tribal citizens can't access the polls, it's not just inconvenient—it's injustice.

We must control the narrative. Our people deserve to be heard—especially now, when so many decisions are being made that directly impact our tribal communities.
